An Act further to amend the Federal Board of Intermediate and Secondary
Education Act, 1975

WHEREAS it is expedient further to amend the Federal Board of Intermediate *
and Secondary Education Act, 1975 (LXVIII of 1975), for the purposes hereinafter
appearing,

It is hereby enacted as follows:—

; 1... Short title and commencement—{}} This Act'may be calied the . Federal Board of Interniediate and Secondary Education (Amendment) Act, 2017.

(2) It shall come into force at once.

2. . Amendment of section-2; Act LXVIII of 1975.—in the Federal Board: of Intermediate and Secondary. Education Act: "T975 (LXVIUL of 1975), hereinafter referred to as the said Act, in section 2,—

(a) in clause (c), for the word "recognized", the word "affiliated" shall be substituted; : :

(b) in 'clause (1), for the words and commas "Areas of Gilgit, Baltistan, Nagar, Haveli and Hunza", the words ~"overnment of Gilgit-Baitistan" shall be substituted.
