further to amend the Federal Employees Benevolent Fund 'and Group : Insurance Act, 1969

Whereas it is expedient further to amend the Federal Employees Benevolent Fund and Group Insurance "Act, 1969 (aka 1968), for the purposes hereinafter appearing;

1. Short title and commencement—(1) This Act may be called the Federal Employees Benevolent Fund and Group, Insurance (Amendment) Act, 2005,

2. - Amendment of section 2s 'Act UI ' of 1969.—In the Federal Employees Benevolent Fund and Group Insurance Act, 1969 (hereinafter

referred to as the said Act, in section. Bjo o.

(c) parents, minor brothers, unmarried, divorced or. widowed daughters. and | sisters of the employee wholly dependent upon him.".

@ in clause (a), the word "and" at the end shall be omitted;

Gi) in clause (b), after the semicolon the word "and" shall be added; and

Gi) after clause (b) amended as aforesaid, the following new clause shall - . be inserted, namely:—

"@) on or after the first day of December 2003, shall be liable to pay to the Benevolent Fund 4 monthly subscription at the rates "specified in column (3) of the Third Schedule;" . ,

4. "Amendment of section 13,. Act IL of 1969.—In the said Act, in

- . section 13, after sub-section' (2), the following new sub-sections shall be added,

"(3) Where, on or after the first day of December 2003, an employee is declared by the prescribed medical authority to have been completely

incapacitated physically or mentally to discharge the duties of his

employment and for that reason is retired or removed from service, he

'shall be entitled to' receive for life such benevolent grant from the Benevolent Fund as specified in column (4) of the Third Schedule; or

where the employee dies during the continuance of his employment,

or during retirement before attaining the age of seventy years, his

spouse shall be entitled to receive for life such benevolent grant from

the Benevolent Fund as specified in column (4) of the Third Schedule:

Provided that, if the deceased employee has no spouse or the spouse dies, other members of his family shall be entitled to receive benevolent grant from Benevolent Fund as prescribed for a period of fifteen years 'or upto the date the deceased employee would have attained the age of seventy years, whichever is earlier:..

Provided further that the said period of fifteen years shall be reckoned from the date from which the deceased employee or, as the case may be, the spouse became eligible for such grant. .

(4) The beneficiaries whose grant period has not expired on 30th day of.

November, 2003 shall be entitled to an increase equal to twenty percent

of the grant sanctioned under the rules' with effect from the first day. \_ of December, 2003, for the remaining period of the grant."
