The following Act of Majlis-e-Shoora (Parliament) received the assent of the President on 30th November, 2010 and is hereby published for general information:—

ACT NO. XX OF 2010

An Act further to amend the Federal Employees Benevolent Fund and Group Insurance Act, 1969

WHEREAS it is expedient further to amend the Federal Employees Benevolent Fund and Group Insurance Act, 1969 (II of 1969), for the purposes hereinafter appearing;

It is hereby enacted as follows:

1 Short title and commencement.—(1) This Act may be called the Federal Employees Benevolent Fund and Group Insurance (Amendment) Act, 2010.

(2) It shall come into force at once and shall be deemed to have taken effect on and from the first day of July, 2009.

2.) Amendment of section 12, Act II of 1969.—In the Federal Employees Benevolent Fund and Group Insurance Act, 1969 (I of 1969), hereinafter referred to as the said Act, in section 12, in sub-section (1), in clause (c), for the words, figure and brackets “specified in column (3) of the Third Schedule” the words “as may be prescribed” shall be substituted.

3. Amendment of section 13, Act II of 1969.—In the said Act, in section 13, in sub-section (3), for the words, figure and brackets “specified in column (4) of the Third Schedule”, occurring twice, the words “may be prescribed” shall be substituted.

4.. Omission of the Third Schedule, Act H of 1969,—In the said Act, the Third Schedule shall be omitted.

The following Act of Majlis-e-Shoora (Parliament) received the assent of the President on 1st December, 2010 and is hereby published for general information:—

ACT No, XXI OF 2010

An Act further to amend the Pakistan Atomic Energy Commission Ordinance, 1965

WHEREAS it is expedient further to amend the Pakistan Atomic Energy Commission Ordinance, 1965 (XVII of 1965), for the purposes hereinafter appearing;

It is hereby enacted as under:—

I. Short title and commencement.—(1) This Act may be called the Pakistan Atomic Energy Commission (Amendment) Act, 2010.

(2) It shall come into force at once.

2. Amendment of section 3B, Ordinance XVUI of 1965.—In the Pakistan Atomic Energy Commission Ordinance, 1965 (XVII of 1965), hereinafter referred to as the said Ordinance, in section 3B,—

(a) in the marginal note for the words, letters and figures “Ordinance XXII of 1969 not to apply Commission” the words, letters and figures “Act 1V of 2008 not to apply to Commission” shall be substituted; and

(b) for the word, comma and figure "Ordinance, 1969" the words, comma, letters, brackets and figures "Act, 2008 (Act IV of 2008)" shall be substituted.

3. Amendment of section 4, Ordinance XVII of 1965.— In the said Ordinance, in section 4,—

(a) in sub-section (1),—

(i) in clause (c), for the word "five" the word "seven" shall be substituted; and

(ii) after clause (c), amended as aforesaid, the heading "Part-time members" and clauses (d) and (e) shall be omitted; and

(b) after sub-section (4) the following new sub-section shall be added, namely:—

"(5) Notwithstanding the composition of the Board prescribed in sub-section (1), the Federal Government may increase or decrease the number of members of the Commission and prescribe the qualifications and mode of appointment in such manner as it may deem appropriate."

4. Omission of sections 8 and 9, Ordinance XVII of 1965.— In the said Ordinance, sections 8 and 9 shall be omitted.
