The following Acts of Farliament received the assent of the President on the 26th November, 1976, and are hereby published for general information :—

ACT No. LXV oF 1976

An Act further to amend the Defence of Pakistan Ordinance, 1971

WHEREAS it is expedient further to amend the Defence of Pakistan Ordinance, 1971 (XXX of 1971), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title, extent and commencement.—_(1) This Act may be called the Defence of Pakistan (Fourth Amendment) Act, 1976.

(2) It extends to the whole of Pakistan.

(3) It shall come into force at once,

2. Amendment of section 12, Ordinance XXX of 1971.—In the Defence of Pakistan Ordinance, 1971 (XXX of 1971), section 12 shall be re-numbered as sub-section (1) of that section and, after sub-section (1) re-numbered as aforesaid, the following new sub-section shall be added, namely :—

“(2) A Special Tribunal shall have the power to punish any person who obstructs or abuses its process or disobeys any of its orders or directions, or does anything which tends to prejudice the case of a party. before it, or tends to bring it or any of its members into hatred or contempt, or does anything which, by law, constitutes contempt of court, with simple imprisonment for a term which may extend to six months, or with fine which may extend to two hundred rupees, or with both.”.

3. Repeal. —The Defence of Pakistan (Fourth Amendment) Ordinance, 1976 (XLII of 1976), is hereby repealed.

ACT No. LXVIII oF 1976

An Act further to amend the National Registration Act, 1973

WHEREAS it is expedient further to amend the National Registration Act, 1973 (LVI of 1973), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement— (1) This Act may be called the National Registration (Amendment) Act, 1976.

(2) It shall come into force at once.

. General amendment, Act LVI of 1973.—In the National Registration Act,

on (LVI of 1973), hereinafter referred to as the said Act, for the expressions

-General", "Joint Registrar-General ", ", "Deputy Registrar-General "

and " Assistant Registrar-General ", wherever occurring, the expressions " Director-

General", "Director", "Deputy Director" and " Assistant Director" shall, respectively, be substituted.

3. Amendment of section 11, Act LVI of 1973.—In the said Act, in section II, in sub-section (1), in clause (k), for the words and commas "with fine not exceeding fifty rupees or, in default of payment of fine, with simple imprisonment for a period not exceeding fifteen days" the words and commas " with rigorous imprisonment for a period not exceeding three months, or with fine not exceeding one thousand rupees, or with both" shall be substituted.

ACT No. LXIX oF 1976

An Act to amend the Flour Milling Control and Development Act, 1976

WHEREAS it is expedient to amend the Flour Milling Control and Development Act, 1976 (LVII of 1976), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Flour Milling Control and Development (Amendment) Act, 1976.

(2) It shall come into force at once.

2. Amendment of section 3, Act LVIE of 1976.—In the Flour Milking Control and Development Act, 1976 (LVIE of 1976) in section 3, in the proviso, after the word "establishment ", the words "or which are run for the benefit of any class of persons or for charitable objects" shall be inserted.

3. Repeal.—The Flour Milling Control and Development (Amendment) Ordinance, 1976 (XXXVI of 1976), is hereby repealed.
