ACT NO. XX OF 2016

An Act further to amend the Foreigners Act, 1946

Whereas it is expedient further to amend the Foreigners Act, 1946
(XXXI of 1946) tor the purposes hereinafter appearing;

Itis hereby enacted as follows:—

I. Short title and commencement.—(1) This Act may be called the
Foreigners (Amendment) Act, 2016.

(2) It shall come into force at once.

2. Substitution of section 14D, Act XXXI of 1946.—In the Fore gners

Act. 1946 (XXXI of 946). hereinatter referred to as the satd Act, for sector. 14D, the following shall be substitutec, namely:—

“14D. Registration of illegal immigraats.—(!) Any foreigner who, before comme wement of this Act, has no permission to stay in Pakistan shall for registration be required to make application on the iormat and in the manner as may be prescribed and shall be registered on that application by the National Database and Registration Authority established under the Nattonal Database and Revistration Authority . Ordinance, 2060 (VIII of 2000). ’

(2) The Fejeral Government may permit a foreigner. registered under sub-section (1), to work in Pakistan at such place. for such period and on payment of such fee as may be prescribed.”.

3. Insertion of new section 17, Act XXXE of 1946.—In the said Act, aller section 16, the foltow ing new section shall be added. namely:- -

“17. Repeal—{1) The Alien Registration Authority (Compositcn and Functicus) Order, 2001 is hereby repealed.

(2) -On repeal under sub-section (1), all assets and liabilities of the Alien Registration Authority shall stand transferred to the National Database and Re;istration Authority and shall be regulated under the Netional Database and Registration Authority Ordinance, 2000 (VILE of 2060).”.
