The following Acts of Parliament received the assent of the President on the 5th March, 1974, and are hereby published for general information :—

ACT No. X of 1974

An Act to provide for the appointment of Legal Advisers to companies

WHEREAS it is expedient to provide for the appointment of Legal Advisers to companies and matters connected therewith ;

} It is hereby enacted as follows :—

. 1. Short title, extent and commencement.—(1) This Act may be called the Companies (Appointment of Legal Advisers) Act, 1974.

(2) It extends to the whole of Pakistan.

(3) It shall come into force at once.

2. Definitions.—In this Act, unless there is anything repugnant in the subject or context,—

(a) "advocate" means an advocate entered in any roll under the provisions of the Legal Practitioners and Bar Councils Act, 1973 (XXXV of 1973);

-(b) "company" means a company formed and registered under the Companies Act, 1913 (VII of 1913), but does not include a company the paid-up capital of which is less than rupees or a company limited by guarantee or an association registered under section 26 of that Act; A (Part 1 of Part 3; and

(c) "Legal Adviser" means a person appointed as such under section 65;

ACT No. XIE OF 1974

An Act further to amend the Succession Act, 1925

WHEREAS it is expedient further to amend the Succession Act, 1925 (XXXIX of 1925), for the purposes hereinafter appearing :

It is hereby enacted as follows :—

1. Short title, extent and commencement.—(1) This Act may be called the Succession (Amendment) Act, 1974.

(2) It extends to the whole of Pakistan.

(3) It shall come into force at once.

2. Amendment of section 211, Act XXXIX of 1925.—In the Succession Act, 1925 (XXXIX of 1925), hereinafter referred to as the said Act, in section 211, in sub-section (2), for the words 'or Jaina' the comma and words ", Jaina or Parsi" shall be substituted.

3. Amendment of section 212, Act XXXIX of 1925.—In the said Act, in section 212, in sub-section (2), after the word "Jaina", the comma and word "Parsi" shall be inserted.

4. Amendment of section 213, Act XXXIX of 1925.—In the said Act, in section 213, for sub-section (2) the following shall be substituted, namely :—

"(2) This section shall not apply in the case of wills made by Muhammadans, and shall only apply—

(a) in the case of wills made by any Hindu, Budhist, Sikh or Jaina, where such wills are of the classes specified in clauses (a) and (b) of section \$7; and

(b) in the case of wills made by any Parsi dying after the commencement of the Succession (Amendment) Act, 1974, where such wills are made within the local limits of the ordinary civil jurisdiction of the Sind and Baluchistan High Court, and where such wills are made outside those limits, in so far as they relate to immovable property situated within those limits. ”.

ACT No. XIII oF 1974

An Act further to amend the Income-tax Act, 1922

WHEREAS it is expedient further to amend the Income-tax Act, 1922 (XI of 1922), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Income-tax (Amendment) Act, 1974.

(2) It shall come into force at once.

2. Amendment of section 2, Act XI of 1922.—In the Income-tax Act, 1922 (XI of 1922), in section 2, in clause (11), in sub-clause (i), in paragraph (b), after the word "behalf", the comma and words ", and the period so determined may commence from any date preceding the date of such determination" shall be inserted.

ACT No. XIV oF 1974

An Act further to aifiend the Pakistan Red Cross Society Act

Wuereas it is expedient further to amend the Pakistan Red Cross Society Act (XV of 1920), for the purposes hereinafter appearing :

It is hereby enacted as follows :—

i. Short tithe and commencement.—(1) This Act may be called the Pakistan Red Cross Society (Amendment) Act, 1974.

(2) It shali come into force at once.

2. Amendment of long title, Act XV of 1920.—In the Pakistan Red Cross Society Act (XV of 1920), hereinafter referred to as the said Act, in the long title, for the words "Pakistan Red Cross Society" the words "Pakistan Red Crescent Society" shall be substituted.

3. Amendment of preamble, Act XV of 1920.—In the said Act, in the preamble, in the second paragraph, for the words " Pakistan Red Cross Society " the words "Pakistan Red Crescent Society ~' shall be substituted.

4. Amendment of section 1, Act XV of 1920.—in the said Act, in section 1, in subsection (1), for the words "Red Cross" the words "Red Crescent" shall be substituted. 7

5. Amendment of section 2, Act XV of 1920.—In the said Act, in section 2, for the words " Pakistan Red Cross Society " the words " Pakistan Red Crescent Society " shall be substituted.

6. Amendment of section 4, Act XV of 1920.—In the said Act, in section 4, for the words "Pakistan Red Cross Society" the words " Pakistan Red Crescent Society " shall be substituted.

7. Amendment of section 7, Act XV of 1920.—In the said Act, in section 7, in clause (a), for the words "Red Cross Depots" the words "Red Crescent Depots" shall be substituted.

8. Amendment of First Schedule, Act XV of 1920.—In the said Act, in the First Schedule, the words "or who are members of His Majesty's Forces

serving Pakistan", wherever occurring, shall be omitted.
