Act No. II of 1989

An Act to amend the Islamabad Real Estate Agents and Motor Vehicles Dealers (Regulation of Business) Ordinance, 1984

WHEREAS it is expedient to amend the Islamabad Real Estate Agents and Motor Vehicles Dealers (Regulation of Business) Ordinance, 1984 (XIII of 1984), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1, Short title and commencement.—(1) This Act may be called the Islamabad Real Estate Agents and Motor Vehicles Dealers (Regulation of Business) (Amendment) Act, 1989,

(2) It shall come into force at once.

2. Amendment of section 10, Ordinance XII of 1984.—In the Islamabad Real Estate Agents and Motor Vehicles Dealers (Regulation of Business) Ordinance, 1984 (XIII of 1984), in section 10, in subsection (2), for the full stop
