The following Acts of Parliament received the assent of the President on the 1st December, 1976, and are hereby published for general information :—

ACT No. LXXII of 1976

An Act to amend the Rice Milling Control and Development Act, 1976

Whereas it is expedient to amend the Rice Milling Control and Development Act, 1976 (LVIII of 1976), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Rice Milling Control and Development (Amendment) Act, 1976.

(2) It shall come into force at once.

2. Amendment of section 3, Act LVIII of 1976.—In the Rice Milling Control and Development Act, 1976 (LVIII of 1976), in section 3 in the proviso, after the word “huller”, the words “or rice mills which are run for the benefit of any class of persons or for charitable objects” shall be inserted.

Repeal.—The Rice Milling Control and Development (Amendment) Ordinance 1976 (XXXVII of 1976), is hereby repealed.

An Act to amend the Cotton Ginning Control and Development Act, 1976

. WHEREAS it is expedient to amend the Cotton Ginning Control and Development Act, 1976 (LIX of 1976), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement—(1) This Act may be called the Cotton Ginning Control and Development (Amendment) Act, 1976.

(2) It shall come into force at once.

2. Amendment of section 3, Act LIX of 1976.—In the Cotton Ginning Control and Development Act, 1976 (LIX of 1976), in section 3, for the full stop at the end a colon shall be substituted and thereafter the following proviso shall be added, namely :—

“ Provided that the Federal Government may, by notification in the official Gazette, exempt any establishment, which is run for the benefit of any class of persons or for charitable objects from the operation of the provisions of this section from such date not preceding the date of commencement of this Act as may be specified in the notification, ”.

3. Repeal.—The Cotton Ginning Control and Development (Amendment) Ordinance, 1976 (XXXVIHI of 1976), is hereby repealed.

ACT No. LXXIV of 1976

An Act further to amend the Land Reforms Regulation, 1972

WHEREAS it is expedient further to amend the Land Reforms Regulation, 1972, for the purpose hereinafter appearing :

AND WHEREAS the Proclamation of Emergency referred to in Art'cle 280 of the Constitution of the Islamic Republic of Pakistan is in force;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Land Reforms (Second Amendment) Act, 1976.

(2) It shall come into force at once.

2. Amendment of paragraph 29 of the Land Reforms Regulation, 1972.—In the said Regulation, in paragraph 29, in the third proviso, in clause (a), for the figures, letters, words and comma “30th day of September, 1976” the figures,

letters, words and comma “30th day of November, 1976” shall be substituted.

3. Repeal. _-The Land Reforms (Second Amendment) Ordinance, 1976 (XXXV of 1976), is hereby repealed.
