The following Acts of Parliament received the assent of the President on the 17th January, 1975, and are hereby published for general information :—
Act No. I of 1975

enacted

An Act to amend the People's Finance Corporation Act, 1972

WHEREAS it is expedient to amend the People's Finance Corporation Act, 1972 (XXIX of 1972), for the purposes hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement—This Act may be called the People's Finance Corporation (Amendment) Act, 1974.

(2) It shall come into force at once

2. Amendment of section 1, Act XXIX of 1972.—In the People's Finance Corporation Act, 1972 (XXIX of 1972), hereinafter referred to as the said Act, in section 1, in sub-section (2), after the word "Pakistan" at the end, the words "and also applies to the business of Corporation transacted outside Pakistan and the persons conducting such business" shall be added.

3. Amendment of section 18, Act XXIX of 1972.—In this said Act, in section 18, for subsection (1) the following shall be substituted, namely :—

"(z) Individuals and firms, having net assets not exceeding fifty thousand rupees in value, and all classes of small business owned or sponsored by such individuals or firms, shall be eligible for loans from the Corporation for such purposes, to such extent and subject to such

- conditions as may be prescribed. "

2. Amendment of section 5, W. P. Ordinance No. IE of 1968.—In the Criminal Law (Special Provisions) Ordinance, 1968 (W. P. Ordinance No. II of 1968), section 5 shall be re-numbered as sub-section (f) of that section and, after sub-section (1) re-numbered as aforesaid, the following new sub-sections shall be added, namely :—

“(2) A Tribunal shall hold its sittings at such place as the Deputy Commissioner may fix, having regard to the safety of the accused and the witnesses and availability of adequate legal assistance to the accused ; and such place may also be a place situated in an area in which this Ordinance is not for the time being in force.

(3) The power of the Deputy Commissioner under sub-section (2) shall, in respect of a place situated beyond the jurisdiction of the Deputy Commissioner by whom the Tribunal has been constituted, be exercisable by the Provincial Government. ”.

3. Repeal.—The Criminal Law (Special Provisions) (Amendment) Ordinance, 1974 (XIV of 1974), is hereby repealed.

Act No. VI of 1975

An Act further to amend the Law Reforms Ordinance, 1972

WHEREAS it is expedient further to amend the Law Reforms Ordinance, 1972 (XII of 1972), for the purpose hereinafter appearing ; a

It is hereby enacted as follows :—

1.. Short title and commencement.—(1) This Act may be called the Law Reforms (Amendment) Act, 1974.

(2) It shall come into force at once.

2. Amendment of section 3, Ordinance XVI of 1972. In the Law Reforms Ordinance, 1972 (XII of 1972), in section 3, in sub-section (2),—

(a) for the words, brackets and figures “clause (2) of Article 201 of the Interim Constitution of the Islamic Republic of Pakistan” the words, brackets and figures “clause (1) of Article 199 of the Constitution of the Islamic Republic of Pakistan” shall be substituted ;

(b) in the proviso—

(i) for, the figure “201” the figure “199” shall be substituted :

(ii) after the words “one appeal”, the words “or one revision or one review” shall be inserted.
