NATIONAL ASSEMBLY OF PAKISTAN
Islamabad, the 5th February, 1973

; The following Act of the National Assembly received the assent of the President on the 2nd February, 1973, and is hereby published for general information :—

ACT No. X of 1973
An Act further to amend the Medical Council Ordinance, 1962

WHEREAS it is expedient further to amend the Medical Council Ordinance, 1962 (XXXII of 1962), for the purpose hereinafter appearing ;

1. Short title and commencement.—(1) This Act may be called the Medical Council (Amendment) Act, 1973.

(2) It shall come into force at once.

2. Amendment of section 1, Ordinance XXXII of 1962.—In the Medical Council Ordinance, 1962 (XXXII of 1962), hereinafter referred to as the said Ordinance, in section 1, for sub-section (1) the following shall be substituted, namely :—

“(1) This Ordinance may be called the Medical and Dental Council

Ordinance, 1962. ”.

3. Amendment of section 2, Ordinance XXXIV of 1962.—In the said Ordinance, in section 2, in clause (b), for the words “ Medical Council ” the words “Medical and Dental Council” shall be substituted.

4. _ Amendment of section 3, Ordinance XXXL of 1962.—In the said Ordinance, in section 3, in sub-section (1),—

{i) for clause (a) the following shall be substituted, namely :—

“(a) one member to be elected by the National Assembly from amongst its members ;

(aa) one member from each Province, to be nominated by the Provincial Government ; ” ;

(ii) for clause (c) the following shall be substituted, namely :—

“(c) four members to be elected from amongst themselves by the registered medical practitioners ;”; and

(iii) for clauses (e) and (f) the following shall be substituted, namely :—

“(e) two members to be elected from amongst themselves by the registered dentists ;

(f) one member to be elected by the teaching staff of each medical institution and dental institution in Pakistan from amongst the professors on its staff, if such institution trains for a medical or dental qualification which is for the time being recognised under this Ordinance ; ”.

5. Amendment of section 6, Ordinance XXXII of 1962.—In the said Ordinance, in section 6, for the words “ Medical Council” the words “ Medical and Dental Council” shall be substituted.
