ACT No. XVIII or 1977

It is hereby enacted as follows :—

1. Short tile and commencement, -(1} This Act may t -.Jled the Jammu and
Kashmir (Administration of Property) (Amendment) Av. +977.

(2} Ht shall came into force at once.

2. Amendment of section 3, Ordinance INT of *-:—In the Jammu and
Kasimir (Adrainistration of Property) Ordinance. 1°°:| (II of 1961), hereinafter
referred to as the said Orcinance, in section 3,—

(a} after sub-section {1}, the followins row sub-section shall be inserted,
namely :--

“ (1A) For the purpose of advising 'be Federal Government in the
exercise of its powers under this Ordinance, the Federal Gover-
ment may constitute a \lanag:ment Committee consisting of such
persons as the Federal Government may deem fit.” ;

ACT No. XIX of 1977

to further amend the Service Tribunals Act, 1972

WHEREAS it is expedient further to amend the Service Tribunals Act, 1973 (LXX of 1973), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement, {1} This Act may be called the Service Tribunals (Amendment) Act, 1977.

(2) It shall come into force at once,

2. Amendment of section 3, Act LXX of 1973.—In the Service Tribunals

Act, 1973 (LXX of 1973) in section 3, in subsection (3), in clause (a), after the word “and”, the words and shall be inserted,

3. Repeal.—The Service Tribunals (Amendment) Ordinance, 1977 (XI of 1977), is hereby repealed,

ACT No. XX of 1977

to amend the Members of Parliament (Salaries and Allowances) Act, 1974

WHEREAS it is expedient to amend the Members of Parliament (Salaries and Allowances) Act, 1974 (XXVII of 1974), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement, (1) This Act may be called the Members of Parliament (Salaries and Allowances) (Amendment) Act, 1977.

(2) It shall come into force at once.

2. Insertion of new section 4A, Act XXVIII of 1974.—In the Members of Parliament (Salaries and Allowances) Act, 1974 (XXVII of 1974), after section 4, the following new section shall be inserted, namely :—

“44. Absence from sittings without leave of the House.—Notwithstanding anything, contained in this Act, a member who, without leave of the House, remains absent for three consecutive days of its sittings, shall not be entitled to receive any daily allowance or conveyance allowance in respect of the days of such absence. ”.

3. Repeal.—The Members of Parliament (Salaries and Allowances) (Amendment) Ordinance, 1977 (XIII of 1977), is hereby repealed,
