The following Act of Majlis-e-Shoora (Parliament) received the assent of the President on the 20th March, 1988 and is hereby published for General information :—
Act No. III oF 1988

An Act further to amend the Members of Parliament (Salaries and Aliowances) Act, 1974

WHEREAS it is expedient further to amend the Members of Parliament (Salaries and Allowances) Act. 1974 (XXVII of 1974). for the purposes herein-after appearing :

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Members of Parliament (Salaries and Allowances) (Amendment) Act, 1988.

(2) It shall come into force at once.

2. Amendment of section 3, Act XXVII of 1974.—In the Members of Parliament (Salaries anti Allowances) Act, 1974 (XXVIII of 1974), hereinafter referred: 'to as' the said Act, ia section 3, in the proviso, for the words " one thousand and five hundred" the words "three thousand " shall 'be substituted.

3. Amendment of section 4, Act XXVII of 1974.

4, for sub-section (2) the following shall be substituted, mele —

“(2) A member who arrives at iiie place of duty or departs from such place shall be entitled to draw daily allowance and conveyance allowance for the day of arrival or the day of departure, as the case may be:

Provided that not more ihan one daily allowance and one conveyance allo wance may, in any case, be claimed in respect of any one day. ”

4. Amendment of section 5, Act XXVII of 1974.—In the said Act, in section 5, in sub-section (1), in clause (b), for the words “ one second class railway fare” the words “one hundred and fifty rupees” shall be substituted.

5s. Amendment of section 6, Act XXVII of 1974.—In the said Act, in section

6,—

(a) in clause (bt). for the word “ first” the word “economy ” shall be substituted :

(b) in clause (c), for the words “one rupee per mile” the words “two ' rupees per kilometre ~ shall be substituted ; and

(c) in ithe proviso, for the words “total amount of the daily allowance ” the words, comma and figures “aggregate of the daily, conveyance and housing allowances admissible under sections 4 and 9” shall be substituted.

6. Amendment of section 7. Act XNXVIL of 1974.—In the said Act, in section 7,—

(a) for the commas and words “.or one sitting of a committee, and the commen-ement of another session or, as the case may be, another sitting ” the words and commas “and the commencement of another session, Or between the termination of one sitting of a committee and the corimencement of another sitting of the committee, ” shall be substituted ; and

(b) in clause (a), for the words and figures “a daily allowance at the rate specified in section 4” the words, comma and figures “daily, conveyance and housing allowances at the rates specified in sections 4 and 9” shall be ‘substituted.

: 7. Amendment of section 8, Act XXVIII of 1974.—In the said Act, ia Bection 8, for the words “or drawn by me from any other source” the words from either House or from Government or a Government Organization ” shall be substituted.

8. Amendment of section 10, Act XXVII of 1974.—In the said Act, in fection 10,—

(a) in sub-section (1), for the words " fifteen thousand ", twice occurring,
the words " thirty thousand " shall be substituted ;
