AcT No. IIL OF 1993

An Act further to amend the Members of Parliament (Salaries and Allowances) Act, 1974

WHEREAS it is expedient further to amend the Members of Parliament (Salaries and Allowances) Act, 1974 (XXVII of 1974), for the purposes hereinafter appearing;

It is hereby enacted as follows:—

1, Short title and commencement.—(1) This Act may be called the Members of Parliament (Salaries and Allowances) (Amendment) Act, 1993.

(2) It shall come into force at once.

2. Amendment of section 4, Act XX VII of 1974.—In the Members of Parliament (Salaries and Allowances) Act, 1974 (XXVII of 1974), hereinafter referred to as the said Act, in section 4, in sub-section (1),—

(a) for the words “one hundred and fifty” the words “three hundred” shall be substituted; and

(b) for the words “one hundred” the words “two hundred” shall be substituted.

3. Insertion of section 4B, Act XXVII of 1974.—In the said Act. after section 4A, the following new section shall be inserted. namely:—

“4B. Sumptuary Allowance—A member shall receive sumptuary allowance at the rate of two thousand rupees per mensem,”.

4. Amendment of section 5, Act XXVII of 1974.—In the said Act. in section 5. in sub-section (1), in clause (c), for the words “two rupees” the words “three rupees” shall be substituted.

5. Amendment of section 6, Act XX VII of 1974.—In the said Act. in section 6, in clause (c), for the word “two” the word “three” shall be substituted.

6. Amendment of section 9, Act XXVII of 1974.—In the said Act. in section 9. for the words “three hundred” the words “four hundred and fifty” shall be substituted.

7. Amendment of section 10, Act XXVII of 1974.—In the said Act. in section 10.—

(a) in sub-section (1),—

(i) for the words “thirty thousand” the words “forty-five thousand” shall be substituted: and

(ii) in the proviso, for the words “thirty thousand” the words “forty-five thousand” shall be substituted: and

(b) in sub-section (2),

(i) for the words “twenty thousand” the words “thirty thousand” shall be substituted: and

(ii) for the words “thirty thousand” the words “forty-five thousand” shall be substituted,

8. Amendment of section 11, Act XXVII of 1974.—In the said Act, in section 11, for the words “two thousand” the words “four thousand” shall be substituted.

9. Amendment of section 11A, Act XXVII of 1974.—In the said Act, in section 11A, for the words “three thousand” the words “five thousand” shall be substituted.
