ACT? No. Xvi OF 1975

An Act to amend the Members ers of the National Assembly (Exempiion from
Preventive Detention and Personal Appearance) Ordinance, 1963

WHEREAS it is expedient to amend the Members of the National Assembly
(Exemption from Preventive Detention and Personal Appearance) Ordinance,
1963, for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title—This Act may be called the Members of the National
Assembly (Exemption from Preventive Detention and Personal Appearance)
(Amendment) Act, 1975.

2. Amendment of section 3 of Ordinance EX of 1963.—In the Members of
the National Assembly (Exemption from Preventive Detention and Personal
Appearance) Ordinance, 1963, in section 3, for sub-section (2) the following shall
be substituted and shall be deemed to have ben so substituted on the eighth day
of February, 1975, namely :—

(2) Nothing in sub-section (1) shall be construed as applying to any
Member who is detained under any such law as is referred to in
sub-section (1)}—

(a) at any time during the period commencing on the fifteenth day
next after the conclusion of a session and ending on the [5th
day before the commencement of the next session; or

(b) for reasons of State connected with defence, external affairs, or
the security of Pakistan or any part thereof.”

ACT No. XVIII of 1975

An Act to amend certain Provincial laws relating to the privileges of the Members of the Provincial Assemblies

WHEREAS it is expedient to amend certain Provincial laws relating to the privileges of the Members of the Provincial Assemblies for the purpose hereinafter appearing ;

AND WHEREAS the Proclamation of Emergency referred to in Article 280 of the Constitution of the Islamic Republic of Pakistan is in force ;

It is hereby enacted as follows :—

1. Short title—This Act may be called the Members of Provincial Assemblies' Privileges (Amendment) Act, 1975.

2. Definition—In this Act, "Provincial laws" mean—

(a) the Provincial Assembly of Baluchistan Privileges Act, 1973 (Baluchistan Act No. VII of 1973);

(b) the Provincial Assembly of the North-West Frontier Province Privileges Act, 1973 (N. W. Fz P. Act No. XVII of 1973);

(c) the Provincial Assembly of the Punjab Privileges Act, 1972 (Punjab - Act No. II of 1972); and

(d) the Provincial Assembly of Sind Privileges Act, 1972 (Sind Act No. VI of 1972).

3. Amendment of section 4 of the Provincial laws.—In each of the Provincial laws, in section 4, in sub-section (2), for clause (a) the following shall be substituted and shall be deemed to have been so substituted on the eighth day of February, 1975, namely :—

"(a) applying to any Member detained under any such law as is referred to therein—

@ at any time during the period commencing on the fifteenth day next after the conclusion of a session of the Assembly and ending on the fifteenth day before the commencement of the next session ; or

(ii) for reasons of State connected with defence, external affairs, or the security of Pakistan or any part thereof; or".
