Act No. .V of 2007

An Act to amend the National Database and Registration Authority  
Ordinance, 2000

WHEREAS it is expedient to amend the National Database and Registration  
Authority Ordinance, 2000 (VIII of 2000), for the purposes hereinafter appearing;

It is hereby enacted as follows:—

1. Short title and commencement.—(1) This Act may be: called the  
National Database and Registration Authority (Amendment) Act, 2007.

(2) It shall come into force at once.

2. Amendment of section 3, Ordinance VIII of 2000.—(1) In the National Database and Registration Authority Ordinance, 2000 (VIII of 2000), hereinafter referred to as the said Ordinance, in section 3,—

\_ in sub-section.(3),—

(i) after the word “and” the words “not less than” shall be inserted; and

(ii) in the proviso, for the full stop, at the end, a colon shall be substituted and thereafter the following further proviso shall be added, namely:

“Provided further that the Federal Government may, from time to time, by notification in the official Gazette, increase or decrease the number of members and prescribe mode of their appointment as it may deem fit.”; and

(b) in sub-section (5), for the words “such shorter term not exceeding one year”, the words “a similar term or terms” shall be substituted; and

(c) in sub-section (8), for the colon a full stop shall be substituted and the - proviso shall be omitted.

3. Amendment of section 42, Ordinance VIII of 2000.—In the said Ordinance, in section 42, for the words, commas, figures and brackets “Wealth Tax Act, 1963 (XV of 1963), the Income Tax Ordinance, 1979 (XXXI of 1979)” the words, comma, figures and brackets “Income Tax Ordinance, 2001 (XLIX of 2001)” shall be substituted.

4. Amendment of section 43, Ordinance VIII of 2000.—In the said Ordinance, in section 43,—

(a) in the marginal note, for the figures and word “XXIII of 1969” the figures and word “XCI of 2002” shall be substituted; and

(b) for the figures, brackets and word “1969 (XXIII of 1969)” the figures, brackets and word “2002 (XCI of 2002)” shall be substituted.
