NATIONAL ASSEMBLY OF PAKISTAN
Islamabad, the 29th June, 1973

The following Acts of the National Assembly received: the assent of the President on the 27th June, 1973, and are hereby published for general in-

formation :—
ACT No. XL of 1973

An Act to provide for the constitution and regulation of the Federal Security Force

Whereas it is expedient to provide for the constitution and regulation of the Federal Security Force to assist the civil administration and the Police Force for ensuring the maintenance of law and order in Pakistan, and for matters connected therewith ;

It is hereby enacted as follows :—

CHAPTER I

1. Short title, application and commencement.—(1) This Act may be called the Federal Security Force Act, 1973.

(2) It shall apply to all members and officers of the Federal Security force wherever they may be serving.

(3) It shall come into force at once.

2. Definitions.—(1) In this Act, unless there is anything repugnant in the subject or context—

(a) "active duty" means the duty to preserve or restore order in any local area in the event of any disturbance therein, and includes such other duty as the Federal Government may, by notification in the official Gazette, specify to be an active duty;

ACT No. XLVI of 1973

An Act further to amend the State Bank of Pakistan Act, 1956

WHEREAS it is expedient further to amend the State Bank of Pakistan Act, 1956 (XXXIII of 1956), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the State Bank of Pakistan (Amendment) Act, 1973.

(2) It shall come into force at once.

2. Amendment of section 17, Act XXXIAM of 1956.—In the State Bank of Pakistan Act, 1956 (XXXII of 1956), in section 17, after clause (18), the following new clause shall be added, namely :—

“(18A) The entering into clearing and payments arrangements with any country or group of countries, on a general or regional or sub-regional basis, participation in the formation and settlement of international payments transactions under such arrangements, and incurring financial and other obligations relating thereto.”.

3. Repeal.—The State Bank of Pakistan (Amendment) Ordinance, 1973 (CXTT of 1973), is hereby repealed.

ACT No. XLVIIT of 1973

An Act further to amend the Pakistan Citizenship Act, 1951

WHEREAS it is expedient further to amend the Pakistan Citizenship Act, 1951 (II of 1951), for the purposes hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Pakistan Citizenship (Amendment) Act, 1973. .

(2) It shall come into force at once.

2. Amendment of section 8, Act II of 1951.—In the Pakistan Citizenship Act, 1951 (II of 1951), hereinafter referred to as the said Act, section 8 shall be renumbered as sub-section (1) of that section and, after subsection (1) renumbered as aforesaid, the following new section shall be added, namely :—

“(2) A subject of the State of Jammu and Kashmir who, being under the protection of a Pakistan passport, is resident in the United Kingdom or such other country as the Federal Government may, by notification in the official Gazette, specify in this behalf, shall, without prejudice to his rights and status as a subject of that State, be deemed to be, and always to have been, a citizen of Pakistan. ”.

3. General Amendment, Act II of 1951.—In the said Act, for the words “Central Government” wherever occurring the words “ Federal Government”

shall be substituted,

4. Repeal.—The Pakistan Citizenship (Amendment) Ordinance, 1973 (I of 1973), is hereby repealed. :
