An Act to consolidate and amend the laws relating to narcotic drugs and  
psychotropic substances

WHEREAS it is expedient to consolidate and amend the laws relating to  
narcotic drugs, psychotropic substances, and control the production, processing  
and trafficking of such drugs and substances;

AND WHEREAS it is expedient to regulate the treatment and rehabilitation  
of narcotic addicts and for matters connected therewith and incidental thereto;

Act No. XXVI of 1997 .

An Act further to amend the Pakistan Rangers Ordinance, 1959

WHEREAS it is expedient further to amend the Pakistan Rangers Ordinance, 1959 (W.P. Ordinance XIV of 1959), for the purposes hereinafter

appearing; — \*

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Pakistan Rangers (Amendment) Act, 1997.

(2) It shall come into force at once.

2. Amendment of section 3, Wer. Ordinance XIV of 1959.—In the Pakistan Rangers Ordinance, 1959 (XIV “of 1959), hereinafter referred to as the said Ordinance, in section 3, in sub-section (4) for the words “Force shall be administered by the Director-General” the words and commas “Federal Government shall, for administration of the Force, appoint Director-Generals” shall be substituted.

3. Amendment of section 4, Ordinance XIV of 1959.—In the said Ordinance, in section 4,— :

(a) for sub-section (1) the following shall be substituted, namely :—

“The Federal Government may appoint as many Director-Generals and Deputy Director-Generals of the Force as it may consider necessary and determine their headquarters, places of duties and area of jurisdiction.”; and

(b) sub-section (2) shall be omitted.

: “A Repeal.—The Pakistan Rangers (Amendment) Ordinance, 1997 (XLVI of 1997), is hereby repealed.
