Acts, Ordinances, President's Orders and Regulations

NATIONAL ASSEMBLY OF PAKISTAN  
Islamabad, the 2nd February, 1973

The following Acts of the National Assembly received the assent of the President on the 31st January, 1973, and are hereby published for general information :—

Act No. III of 1973

An Act to provide for the establishment of the Pakistan Science Foundation

\_ Whereas it is expedient to provide for the establishment of the Pakistan Science Foundation and for matters ancillary thereto ;

It is hereby enacted as follows :—

1. Short title, extent and commencement.—(1) This Act may be called the Pakistan Science Foundation Act, 1973.

(2) It extends to the whole of Pakistan.

(3) It shall come into force at once.

2. Definitions.—In this Act, unless there is anything repugnant in the subject or context,—

{a} " Board" means the Board of Trustees of the Foundation ;

{b} " Chairman" means the Chairman of the Foundation ; and

(c) "Foundation" means the Pak'stan Science Foundation established under this Act.

Act No. IV of 1973

An Act further to amend the Pakistan Tobacco Board Ordinance, 1968

WHEREAS it is expedient further to amend the Pakistan Tobacco Board Ordinance, 1968 (J of 1968), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Pakistan Tobacco Board (Amendment) Act, 1973.

(2) It shall come into force at once.

2. Amendment of section 2, Ordinance I of 1968.—In the Pakistan Tobacco Board Ordinance, 1968 (J of 1968), in section 2, in clause (f) after the words “*nicotiana tobaccum*”, the words “ or *nicotiana rustica*” shall be inserted.

3. Repeal.—The Pakistan Tobacco Board (Second Amendment) Ordinance, 1972 (LV of 1972), is hereby repealed.

Act No. V of 1973

An Act further to amend the Cotton Act, 1957

WHEREAS it is expedient further to amend the Cotton Act, 1957 (XXXVIII of 1957), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1, Short title and commencement.—(1) This Act may be called the Cotton (Amendment) Act, 1973.

(2) It shall come into force at once.

2. Amendment of section 11, Act XXXVIII of 1957.—In the Cotton Act, 1957 (XXXVI of 1957), section 11 shall be re-numbered as sub-section (1) of that section and, after sub-section (1) re-numbered as aforesaid, the following new sub-section shall be added, namely :—

“(2) The Cotton Board may, by general or special order in writing, direct that such of its powers, including powers which have been directed under sub-section (1) to be exercised by the Cotton Board, shall, in relation to such matters and subject to such conditions, if any, as may be specified in the order, be exercisable also by the Chairman of the Board or such member thereof as may be so specified :

Provided that orders passed under the powers thus delegated shall be laid before the Board at its next meeting. ”.

3. Repeal.—The Cotton (Amendment) Ordinance, 1972 (LIV of 1972), is hereby repealed.
