The following Acts of Majlis-e-Shoora (Parliament) received the assent of the President on the 26th July, 1992, and are hereby published for general information —

Act No, XIV OF 1992

An Act further to amend the Pakistan Rangers Ordinance, 1959

Whereas it is expedient further to amend the 'Pakistan Rangers

Ordinance, 1959 (W.P. Ordinance No. XIV of 1959), for the purpose hereinafter appearing;

It is hereby enacted as follows:—

1. Short title and commencement.—(1) This Act may be called the Pakistan Rangers (Amendment) Act, 1992,

(2) [It shall come into force at once.

2. Amendment of section 15, W.P. Ordinance No. XIV of 1959.—In the Pakistan Rangers Ordinance, 1959 (W.P. Ordinance No. XIV of 1959), in section 15, in sub-section (1) in the proviso, for the full stop at the end a colon

shall be substituted and thereafter the following new proviso shall be added, namely :—

“Provided further that no, disciplinary action against a member of the

Force shall be taken without providing him an opportunity of being heard”.

Act No, XV OF 1992

An Act further to amend the passport Act, 1974

WHEREAS it is expedient further to amend the Passport Act, 1974 (XX of 1974). for the purpose hereinafter appearing:

It is hereby enacted as follows :—

1. Short title and commencement—(1) This Act may be called the Passport (Amendment) Act, 1992.

(2) It shall come into force at once.

2, Amendment of section 8, Act XX of 1974.—In the Passport Act, 1974 (XX of 1974), in section 8, in sub-section (2), for the proviso the following shall be substituted, namely :—

“Provided that no such notice need be given in the case of an order impounding a Passport if it is necessary in the opinion of the Secretary or such other officer to take immediate action, but an opportunity to show cause against the making of the order shall be afforded to the person to whom the order relates, within two weeks from the making of the order.”.

Act NO. XVI OF 1992.

An Act to provide for the regularization of the appointments of certain medical officers appointed on adhoc basis

WHEREAS it is expedient to provide for the regularization of the appointments of certain medical officers appointed on adhoc basis;

It is hereby enacted as follows;—

‘ 1. Short title and commencement.—(1) This Act may be called the Medical Officers (Regularization of Appointments) Act, 1992.

(2) It shall come into force at once.
