An Act further to amend the Political Parties act, £962

WHeReAS it is expedient further to amend the Potitical Purties Act, 1962
(TL of 1962), tor the purpose hereinafter appearing ;

Tt is hereby enacted as follows :—

- 1, Short Ge and commencement. -(1) This Act may be called the Political
Parties (Amendment) Act, 1977,
- (2) [et shall come into force ut once.
2. Substitutien of section 8, Act III of 1962. In the Political Parties Act.
3962 (IH of 1962}, for section 8 the following shall be substituted, namely :—
- “3. Certain disqualifications for being «@ member of Parliament or a Pro-
vincial Assembly -A person who has: -

(a) at any time on or after the twentieth day of December, 1973, been an Office-bearer of a political party dissolved under sub-section (2) of section 6 and has not, before a declaration in respect of such party is made under sub-section (1) of that section, resigned from, or publicly announced his dissociation with, such party ; or
(b) been convicted under section 7,

shall be disqualified from being a member of Parliament or a Provincial Assembly and from being elected or chosen as such a member for a period of five years from the date of such dissolution or conviction, as the case may be,
