The following Acts of Parliament received the assent of the President on
the 19th May, 1976, and are hereby published for general information :—

ACT No. XXXII of 1976

An Act further to amend the Provincial Motor Vehicles Ordinance, 1965

WHEREAS it is expedient further to amend the Provincial Motor Vehicles
Ordinance, 1965 (West Pakistan Ordinance No. XIX of 1965), for the purpose
hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Provin-
cial Motor Vehicles (Amendment) Act, 1976.

(2) It shall come into force at once and shall be deemed to have taken effect
on the 18th day of December, 1975.

2. Amendment of Sixth Schedule, W.P. Ordinance No. XIX of 1965.—in
the Provincial Motor Vehicles Ordinance, 1965 (West Pakistan Ordinance
No. XIX of 1965), in the Sixth Schedule, after the entry "Mekran" in the first
column and the entry relating thereto in the second column the following entries
shall be inserted, namely :—

" Nasirabad ND

Peshin PN

Khuzdar KZ

Kachhi KI

Kohlu KU.".

3. Repeal—The West Pakistan (Baluchistan 2nd Amendment) Motor Vehicles Ordinance, 1975 (Baluchistan Ordinance No. IV of 1975), and the West Pakistan (Baluchistan 3rd Amendment) Motor Vehicles Ordinance, 1976 (Baluchistan Ordinance No. TH of 1976), are hereby repealed.

ACT No. XXXIV of 1976

An Act to amend the Provincial Service Tribunals (Extension of Provision of the Constitution) Act, 1974

WHEREAS the Provincial Assembly for Baluchistan has made in the form of a resolution the request that the provisions of clause (2) of Article 212 of the Constitution of the Islamic Republic of Pakistan be extended to the Service Tribunals established under Act of that Assembly ;

AND WHEREAS it is necessary to amend the Provincial Service Tribunals (Extension of Provisions of the Constitution) Act, 1974 (XXXII of 1974), for the purpose of extending the aforesaid provisions of the Constitution to the Service Tribunals established under Act of the Provincial Assembly for Baluchistan ;

It is hereby enacted as follows :—

1. Short title and commencement.—({1} This Act may be called the Provincial Service Tribunals (Extension of Provisions of the Constitution) (Amendment) Act, 1976.

(2) It shall come into force at once.

2. Amendment of preamble, Act XXXII of 1974.—In the Provincial Service Tribunals (Extension of Provisions of the Constitution) Act, 1974 (XXXII of 1974), hereinafter referred to as the said Act, in the preamble, after the word “for”, the word and comma “ Baluchistan,” shall be inserted.

3. Amendment of section 2, Act XXXH of 1974.—In the said Act, in section 2, for the words “Provincial Assemblies of” the words and comma “ Provincial Assemblies for Baluchistan,” shall be substituted.

ACT No. XXXV of 1976

An Act further to amend the National Guards Act, 1973

WHEREAS it is expedient further to amend the National Guards Act, 1973 (LXI of 1973), for the purposes hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—This Act may be called the National Guards (Amendment) Act, 1976.

(2) It shall come into force at once.
