The following Acts of Parliament received the assent of the President on the 28th May, 1977, and are hereby published for general information.

ACT No ME Or PPT

An Act to provide for effective prevention of smuggling and for punishment of offenders and for matters connected therewith.

WHEREAS it is expedient to provide for effective prevention of smuggling and for matters connected therewith;

It is hereby enacted as follows:

CHAPTER 1
PRELIMINARY

1. Short title, extent and commencement. (1) This Act may be called the Prevention of Smuggling Act, 1977,

(2) It extends to the whole of Pakistan.

(3) It shall come into force on such days as the Federal Government may, by notification in the official Gazette, appoint.

2. Definitions.—(1) In this Act, unless there is anything repugnant in the subject of context—

(a) "associate" in relation to a person, includes

(i) any individual who is or has been residing in the residence or premises, including a house and servant-quarters of such person;

(ii) any individual who is or has been wanes before or keeping the accounts of such person:

ACT No. XVI o or 1977

An Act ta amend the Representation of the People Act, 1976

WHEREAS it is expedien: to amend the Representation of the People Act, 1976 (LXXX¥ of 1976), for the purpose hereinafter appearing ;

ly is hereby enacted as follows :—

]. Short tile and commencement.—{1) This Act may he called the Representa-tion of the People (Amendment) Act, 1977.

{2) It shall come into force al once.

2. Insertion of new section 103A, Act LXXXV of 1976,—In the Repre-sentation of the People Act, 1976 (LXXXV of 1976), after section 103, ths new section shall be inserted, namely :—

“103A. Power of Commission to punish for contempt.—The Commis-sion shall have the same power us the High Court has to punish eny person for contempt of court and the Cuntempt of Court Act, 1976 (LXIV of 1976), shall have effect accordingly as if reference therein

to a “court™ and to a “judge” were a reference, respectively, to the “ Commission” and “,a member of the Commission 7. ”.

3. Repeal—The Representation of the People (Amendment} Ordinance, 1977 (VIII 'of 1977), is hereby repealed.

ACT No. XVII OF 1977

An Act further to amend certain laws relating to industrial relations and welfare of workers

WHEREAS it is expedient further to amend certain laws relating to industrial fejations and welfare of workers for the purposes hereinafter appearing ;

Tt is hereby enacted as follows :—

1. Short ti@e, extent and commencement.--{1) This Act may be calied the Labour Laws (Amendment) Act, 1977,

(2) It extends to the whole of Pakistan.

(3) Tt shall come into force at once.

2. Amendment of certain laws.- The jaws specified in the First Schedule shall be amended in the manner specified in the fourth column thereof.

3. Repeal.—The Labour Laws (Amendment) Ordinance, 1977 (IX cf 1977), is hereby repealed.
