The following Acts of the National Assembly received the assent of the President on the 9th February, 1973, and are hereby published for general

information :—  
ACT No. XXIE of 1973

An Act further to amend the West Pakistan Industrial and Commercial Employment (Standing Orders) Ordinance, 1968.

WHEREAS it is expedient further to amend the West Pakistan Industrial and Commercial Employment (Standing Orders) Ordinance, 1968 (West Pakistan Ordinance No. VI of 1968). for the purposes hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the West Pakistan Industrial and Commercial Employment (Standing Orders) (Amendment) Act, 1973.

(2) It shall come into force at once.

2. Amendment of section 1, W.P. Ordinance No. VI of 1968.—In the West Pakistan Industrial and Commercial Employment (Standing Orders) Ordinance, 1968 (W.P. Ordinance No. VI of 1968), hereinafter referred to as the said Ordinance in section 1. in sub-section (4),

(a) for clauses (a) and (b) the following shall be substituted, namely :—

“(a) every industrial establishment or commercial establishment wherein

ACT No. XXVII of 1973

An Act to extend the Jurisdiction of the Supreme Court and the High Court to certain Tribal Areas

WHEREAS it is expedient to extend the jurisdiction of the Supreme Court and the High Court to certain Tribal Areas ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Supreme Court and High Court (Extension of Jurisdiction to certain Tribal Areas) Act, 1973.

(2) It shall come into force at once.

2. Extension of Jurisdiction of Supreme Court.—The Supreme Court of Pakistan shall have, in relation to the Provincially Administered Tribal Areas of Chitral, Dir, Kalam, Swat and Malakand Protected Area, the same Jurisdiction as it has in relation to the other areas of the North-West Frontier Province.

3. Extension of Jurisdiction of High Court.—The Peshawar High Court shall have, in relation to the Tribal Areas specified in section 2, the same Jurisdiction as it has in relation to the other areas of the North-West Frontier Province.

4. Repeal.—The Supreme Court and High Court (Extension of Jurisdiction to Tribal Areas) Order, 1970 (P.O. No. 28 of 1970), is hereby repealed

ACT No. XXVIII of 1973

An Act to reconstitute and reorganize the University of Islamabad

WHEREAS it is expedient to reconstitute and reorganize the University of Islamabad for the purpose of improving its administration ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the University of Islamabad (Reconstitution and Reorganization) Act, 1973 &

(2) It shall come into force at once.

2. Definitions.—In this Act, unless there is anything repugnant in the subject or context,—

(a) “Academic Council” means the Academic Council of the University ;

(b) “Authority” means an Authority of the University specified in section 18;
