Act No, XXII of 1991

An Act further to amend the Transfer of Managed Establishment Order, 1978

WHEREAS it is expedient further to amend the Transfer of Managed Establish-
ment Order, 1978 (P.O. No. 12 of 1978), for the purpose hereinafter appearing ;

It is hereby enacted as follows ;—

1, Short title and commencement.—(1) This Act may be called the Trans-
fer of Managed Establishments (Amendment) Act, 1991.

(2) It shall come into force at once,

2. Substitution of Article 4, P.O. No. 12 of 1978—In the Transfer of
Managed Establishments Order, 1978 (P.O. No. 12 of 1978), for Article 4 the
following shall be substituted, namely :—

“4. Transfer of shares and proprietary interest, etc—(1) If the Federal
Government considers it necessary in the public interest to transfer the shares
or proprietary interests in respect of a managed establishment acquired by it under
Article 7B of the said Order, the Federal Government may, through a public adver-
tisement, invite bids for the transfer of the shares or proprietary interests.

(2) On receipt of bids in pursuance of an invitation under clause (1), the Federal Government shall offer the transfer of shares or proprietary interests to the persons specified in the Schedule on the highest bid so received and on such terms and

conditions as it may see fit. 2 =

Q. If the persons specified in the Schedule do not accept, the offer under clause (2), the Federal Government may transfer the same to such persons and on such terms and conditions, as it may deem fit.

(4) In case of transfer of shares or proprietary interests in respect of a managed establishment under clause (2) or clause (3), the provisions of Articles 5, 6, 7, 8, 9, 10 and 11, and the Schedule to this Order shall not apply."
