The following Acts of Parliament received the assent of the President on the 24th July, 1975, and are hereby published for general information :—

ACT No, LXI of 1975

An Act further to amend the Employees' Cost of Living (Relief) Act, 1973

Whereas it is expedient further to amend the Employees' Cost of Living (Relief) Act, 1973 (1 of 1974), for the purposes hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Employees' Cost of Living (Relief) (Amendment) Act, 1975.

(2) It shall come into force at once.

2. Amendment of section 2, Act I of 1974.—In the Employees' Cost of Living (Relief) Act, 1973 (1 of 1974), hereinafter referred to as the said Act, in section 2, in clause (b), the words and commas "a person employed on wages equal to, or exceeding one thousand and one hundred rupees per month, or" shall be omitted.

3. Amendment of section 3, Act I of 1974.—In the said Act, in section 3,—

(a) in sub-section (2),—

(i) after the word "employee", the words "whose wages do not exceed one thousand and one hundred rupees" shall be inserted ;
and

(ii) in clause (b), after the word "rupees" occurring for the second time, the words " but are less than one thousand and | one hundred tupees" shall be inserted ; and

ACT No. LXIII of 1975

An Act to validate certain President's Orders, Martial Law Regulations, Martial Law Orders and other laws.

Whereas clause (1) of Article 270 of the Constitution of the Islamic Republic of Pakistan provides that Parliament may by law validate all Proclamations, President's Orders, Martial Law Regulations, Martial Law Order and other laws made between the twenty-fifth day of March, 1969, and the nineteenth day of December, 1971 ;

AND WHEREAS it is expedient to validate certain President's Orders, Martial Law Regulations, Martial Law Orders and other laws made as aforesaid ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Validation of Laws Act, 1975.

(2) It shall come into force at once.

2. Validation of laws.—The laws mentioned in the Schedule are hereby declared to have been validly made by competent authority.

ACT No. LXIV oF 1975

An Act to repeal the Malaria Eradication Board Ordinance, 1961

WHEREAS it 1s expedient to repeal the Malaria Eradication Board Ordinance, {961 (XVIII of 1961), and to provide for matters incidental thereto ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Malaria Eradication Board (Repeal) Act. 1975. ;

2. Repeal, etc.—(1) The Malaria Eradication Board Ordinance, 1961 'XVIII of 1961), hereinafter referred to as the Ordinance, is hereby repealed.

(2) Upon the repeal of the Ordinance,—

(a) notwithstanding anything contained in any contract or agreement or in the conditions of service, the officers and other employees of the Malaria Eradication Board, hereinafter referred to as the Board. shall stand transferred to the Federal Government on such terms and conditions as may be laid down by the Federal Government ;

all rights, properties, assets, debts, liabilities and obligations of the Board shall be the rights, properties, assets, debts, liabilities and obligations of the Federal Government ;

{c) any contract made by the Board before such repeal shall be deemed to have been made by the Federal Government; and

(d) all suits and other legal proceedings instituted by or against the Board before such repeal shall be deemed to be suits and proceed- ings instituted by or against the Federal Government and may be proceeded or otherwise dealt with accordingly.

(3) The Federal Government may, for the purpose of removing any diffi- culty in relation to the transfer and other matters referred to in sub-section (2), make such order as it considers expedient and any such order shall be deemed to be, and given effect to, as part of the provisions of this Act.
