The following Acts of Majlis-e-Shoora (Parliament) received the assent of the President on the 29th November, 1994, and are hereby published for general information :—

Act No. XXI of 1994

An Act further to amend the West Pakistan Family Courts Act, 1964

WHEREAS it is expedient further to amend the West Pakistan Family Courts Act, 1964 (W. P. Act XXXV of 1964), for the purposes hereinafter appearing :

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the West Pakistan Family Courts (Amendment) Act, 1994.

(2) It shall come into force at once.

2. Substitution of section 3, W. P. Act XXXV of 1964.—In the West Pakistan

Family Courts Act, 1964 (XXXV of 1964), hereinafter referred to as the said Act, for section 3 the following shall be substituted, namely :—

“3. Establishment of Family Courts—(1) Government shall establish one

1952 (XXXI of 1952), in section 1A, for clause (1) the following shall be substituted, namely :—

“(1) civil defence includes any measures not amounting to actual combat, for affording defence against any form of hostile attack by a foreign power or for depriving any form of hostile attack by a foreign power of its effect, whether such measures are taken before, during or after the time of the attack, and includes remedial measures during calamity or disaster in peace time;”.

Act No. XXIII OF 1994

An Act further to amend the Weights and Measures (International System) Act, 1967

WHEREAS it is expedient further to amend the Weights and Measures (International System) Act, 1967 (V of 1967), for the purpose hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the weights and Measures (International System) (Amendment) Act, 1994.

(2) It shall come into force at once.

2. Amendment of section 2, Act V of 1967.—In the Weights and Measures (International System) Act, 1967 (V of 1967), in section 2, for clause (25) the following shall be substituted, namely :—

“(25) “weighing instrument” means any instrument for measuring weight and includes scales, with the weights belonging thereto, scalebeams, balances, spring balances, steelyards, electronic and other weighing machines;”.
