Acts, Ordinances, President's Orders and Regulations

NATIONAL ASSEMBLY OF PAKISTAN

fslamabad, the Tth February, 1973

The following Acts of the National Assembly received the assent of the President on the 4th February, 1973, and are hereby published. for general information :—

ACT No. XIV or 1973

An Act further to amend the Workmen's Compensation Act, 1923

WHEREAS it is expedient further to amend the Workmen's Compensation Act. 1923 (Vil of 1923), for the purposes hereinafter appearing ;

It is hereby enacted as follows :—

1, Short title and commencement.—(i) This Act may be called the Workmen's Compensation (Amendment) Act. 1973.

(2) It shall come into force at once.

2. Amendment of section 2, Act VIII of 1923.—In the Workmen's Compensation Act, 1923 (VII of 1923), hereinafter referred to as the said Act, in section 2. in sub-section (1), in clause (nm), in sub-clause (ii), for the words " five hundred " the words "one thousand" shall be substituted.

3. Amendment of section 4, Act VIIT of 1923.—In the said Act, in section 4, in sub-section (1),—

(a) in clause A, in sub-clause (ii), for the words "four hundred" the words "four thousand" shall be substituted ;

(b) in clause B, in sub-clause (ii), for the words "two thousand" the words "ten thousand" shall be substituted ;

(c) in clause D, in sub-clause (ii), for the word "thirty" the word : "seventy-five " shall be substituted ; and ;

: (d) in the proviso, in clause (a), after the word " treatment", at the end, the words "and the half-monthly payments made. for the firse four months of disablement" shall be added.

4. Amendment of section 16, Act VIII of 1923.—In the said Act, in section 10, in sub-section (1), for the words "one year", occurring twice, the words \* three years" shall be substituted.

5. Amendment of section 18A, Act VHI of 1923.—In the said Act, in section 18A. sub-section (1A) shall be omitted.

6. Amendment of Schedule Hi, Act VIII of 1923.—In the said Act, in Schedule IT,—

(a) in clause (i), the words "in a clerical capacity or" shall be omitted ;

(b) in clause (ii), the words "but not persons employed solely in a clerical capacity in any room or place where no manufacturing process is being carried on" shall be omitted ;

{c) in clause (v), the commas and words ",other than clerical work, " shall be omitted ; and -

(d) in clauses (x), (xiv), (xviii) and (xix), the commas and words ", other- wise than in a clerical capacity." wherever occurring shall be omitted.

7. Amendment of Schedule IV, Act VI of 1923.—In the said Act, in Schedule TV, in column 1, for the figure "500" the figure "1,000" shall be substituted.

8. Repeal—The Workmen's Compensation (Amendment) Ordinance, 1972 (XL of 1972), is hereby repealed. .

ACT No, XV or 1973

"An Act further to amend the West Pakistan Employees' Social Security Ordinance, 1965

,\_ WHEREAS it is expedient further to amend the West Pakistan Employees'. Social Security Ordinance, 1965 (West Pakistan Ordinance No. X of 1965), for. the purposes hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called Pakistan Employees' Social Security (Amendment) Act, 1973. the West

(2) It extends to the whole of Pakistan.

. Amendment of section 35, W.P. Ordinance No. X of 1965.—In the "West" Pakistan Employees' Social Security Ordinance, 1965 (W. P. Ordinance No. X of 1965), hereinafter referred to as the said Ordinance, in section 35, for sub-section (2) the following shall be substituted, namely :—

(2) A secured person shall be entitled to receive sickness benefits throughout the period of sickness :—

Provided that during a continuous period of three hundred and sixty-five days such benefit shall not be allowed for a period exceeding—

(a) one hundred and eighty days, in case he has been suffering from tuberculosis ; and

(b) one hundred and twenty-one days, in case he has been suffering from any other disease :—

Provided further that he shall not be entitled to receive such benefit for the first two days of his sickness if such sickness does not, within fifteen days, follow the previous period of sickness for which he received or was entitled to receive such benefit. ”.

3. Amendment of section 37, W. P. Ordinance No. X of 1965.—In the said Ordinance, in section 37 for the word "fifty" the words "five hundred"

shall be substituted.

4. Amendment of section 67, W.P. Ordinance No. X of 1965.—In the said Ordinance, in section 67, sub-section (4) shall be omitted.

5. Repeal of Ordinance No. XLI of 1972.—The West Pakistan Employees' Social Security (Amendment) Ordinance, 1972 (XLI of 1972), is hereby repealed.

ACT No. XVI of 1973

An Act further to amend the Factories Act, 1934

WHEREAS it is expedient further to amend the Factories Act, 1934 (XXV of 1934), for the purposes hereinafter appearing ;

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Factories (Amendment) Act. 1973.

(2) It shall come into force at once.

2. Amendment of section 2, Act XXV of 1934.—In the Factories Act, 1934 (XXV of 1934), hereinafter referred to as the said Act, in section 2,—

(a) in clause (h), after the word " employ: " occurring for the first time, the words " directly or through an agency" shall be inserted ; and
