hereinafter appearing ;

It is hereby enacted as follows :—

1, Short title and commencement—(1) This Act may be called the
Modaraba Companies and Modaraba (Floatation and Control) (Amendment)
Act, 1985.

An Act to amend the Korangi Fisheries Harbour Authority Ordinance, 1982

WHEREAS it is expedient to amend the Korangi Fisheries Harbour Authority Ordinance, 1982 (XV1 of 1982), for the purposes hereinafter appearing ;

Tt is hereby enacted as follows :—

1, Short fitie and cummmencement.—(I) This Act may be called the Korangi Fisheries Harbour Authority (Amendment) Act, 1985.

(2) Tt shall come into force at once,

2, Amendment of section 27, Ordinance XVI of 1982.--In the Korangi Fiskeries Harbour Authority Ordinance, 1982 (XVI of 1982), in section 27, in sub-section (1), for the full-stop at the end a colon shall be substituted and thereafter the following proviso shall be added, namely ;—

* Provided that a suit instituted without such notice shall not be dismissed only on that ground, but the plaintiff shall not be entitled to any costs. ”,

3. Repeal—tThe Korangi Fisheries Harbour Authority (Amendment) Ordinance, 1985 (XXII of 1985), is hereby repealed.

Wuereas it ig expedient further to amend the West Pakistan Maternity Benefit Ordinance, 1958 (W.P. Ordinance No. XXX of 1958), for the purposes hereinafter appearing ;

It is hereby enacted as follows

1. Shori tile and commencement—(1) This Act may be called the West Pakistan Maternity Benefit (Amendment) Act. 1985,

(2) It shall come into force at once.

2, Amendment of section 6, W.P. Ordinance No, XXXII of 1958.—In the West Pakistan Maternity Benefit Ordinance, 1958 (W. P. Ordinance No. KXX1) of 1958), hereinafter referred to as the said Ordinance, in section 6~~

in sub-section (2), for the commas and words “,or, if she has made no such nomination, to her legal representative” the words and commas “for the benefit of all her legal representatives, or, if she has made no such nomination, to all her legal representatives” shall be substituted.

3. Amendment of section 11, W. P. Ordinance No. XXX of 1958.—In the said Ordinance, in section 11,—

after the word “woman”. occurring for the first time, the words “or the person nominated by her or any of her legal representatives ” shall be inserted ;

for the words “employer or a woman”, occurring for the second time, the word “ applicant” shall be substituted ; and

after the words “such appeal”, the commas and words “, which shall be taken after affording to the applicant an opportunity of being heard,” shall be inserted.

4. Repeal—The West Pakistan Maternity Benefit Amendment Ordinance, 1985 (XXII of 1985), is hereby repealed.
