THE ABKARI LAWS (SIND AMENDMENT) ACT, 1975.

An Act to further amend the Sind Abkari Act, 1878, the Sind Consumption of Intoxicants Restriction Act, 1940 and the West Pakistan Prohibition of Opium Smoking Ordinance, 1960.

WHEREAS it is expedient to further amend the Sind Abkari Act, 1878, the Sind Consumption of Intoxicants Restriction Act, 1940 and the West Pakistan Prohibition of Opium Smoking Ordinance, 1960, in the manner hereinafter appearing:

It is hereby enacted as follows:-

(1) This Act may be called the Abkari Laws (Sind Amendment)

with imprisonment which may extend to
five years, or with both", the words and
commas "one lac rupees, or with
imprisonment which may extend to
seven years, or with both", shall be
substituted.

3. In section 51, for the words and
commas "five thousand rupees, or with
imprisonment for a term which may
extend to three years, or with both", the
words and commas "one lac rupees, or
with imprisonment for a term which may
extend to seven years, or with both"
shall be substituted; and

4. In section 55-A, in the proviso, for
the words "five thousand rupees", the
words "one lac rupees" shall be
substituted.

1. In section 3, 4 and 5.-

(a) for the words "three years or with
fine which may extend to five
thousand rupees", the words
"seven years or with fine which
may extend to one lac rupees"
shall be substituted; and

with fine which may extend to one lac
rupees, or with both" shall be substituted.
