THE N.E.D UNIVERSITY ENGINEERING AND TECHNOLOGY
(AMENDMENT) ACT, 1986

[26TM November 1986].

An Act to amend the N.E.D University of Engineering and Technology Act, 1977.

WHEREAS it is expedient to amend the N.E.D University of Engineering and Technology Act, 1977, in the manner hereinafter appearing;

It is hereby enacted as follows: —

1. (1) This Act may be called the N.E.D University of Engineering and Technology (Amendment) Act, 1986.

(2) It shall come into force at once.

2. In the N.E.D University of Engineering and Technology Act, 1977, hereinafter referred to as the said Act, in section 2, after clause (m), the following shall be inserted :—

“(mm) “Pro-Vice-Chancellor” means the Pro-Vice-Chancellor of the University;”.

3. In the said Act, in section 15, in sub-section (1), after clause (i), the following shall be inserted :—
“(i-a) the Pro-Vice-Chancellor;”.

4. In the said Act, in section 17, in sub-section (1), after clause (i), the following shall be inserted :—

“(i-a) the Pro-Vice-Chancellor;”.

5. In the said Act, in section 26, after clause (i), the following shall be inserted :—

“(i-a) the Pro-Vice-Chancellor;”.

6. In the said Act, after section 28, the following shall be inserted :—

“Pro-Vice- 28-A. (1) The Chancellor may in consultation with the Vice-Chancellor, appoint a Pro-Vice-Chancellor for the main campus or for additional campus, if any, or for both the campuses jointly or separately, on such terms and

conditions and for such period not exceeding four years at a time as the Chancellor may determine.

(2) Where a Pro-Vice-Chancellor is appointed under sub-section (1), he shall, notwithstanding anything contained in this Act, exercise such powers and perform such functions of the Vice-Chancellor or such other powers and functions, in respect of the campus for which he is appointed as the Chancellor may delegate to him.”.

7. The N.E.D University of Engineering and Technology (Amendment) Ordinance, 1986, is hereby repealed.
