THE PRIVATE UNIVERSITIES AND EDUCATIONAL INSTITUTES LAWS
(AMENDMENT) ACT, 2004

[12th November, 2005]

An act to amend certain laws relating to the Private Universities and Educational Institutes in force in the Province of Sindh.

WHEREAS it is expedient to amend certain laws relating to the Preamble. Private Universities and Educational Institutes in force in the Province of

Sindh, in the manner hereinafter appearing;

It is hereby enacted as follows:-

Short title and

(1) This Act may be called the Private Universities and Educational commencement. Institutes Laws (Amendment) Act, 2004.

(2) It shall come into force at once.
