to amend the Shahdadpur Institute of Medical Sciences Act, 2011.

WHEREAS it is expedient to amend the Shahdadpur Institute of Medical Preamble.
Sciences Act, 2011, in the matter hereinafter appearing;

It is hereby enacted as follows:-

1. (1) This Act may be called the Shahdadpur Institute of Medical Sciences Short title and (Amendment) Act, 2017. commencement
- (2) It shall come into force at once.

2. In the Shahdadpur Institute of Medical Sciences Act, 2011, hereinafter referred Amendment of to as the said Act, in section 7, in sub-section (1), for the word "Governor", the section 7 of Sindh Act

words "Chief Minister" shall be substituted. No. XI of 2011.

3. In the said Act, in section 8, for sub-section (1), the following shall be Amendment of substituted:- section 8 of Sindh Act

"(1) The general direction and administration of the Institute and its affairs No. X1 of 2011. shall vest in the Board consisting of the following:-

(i) Minister Health or if there is no Minister Health, Chairman
Member of Cabinet nominated by the Chief
Minister

(ii) Member of Provincial Assembly from the Member
Constituency where the Institute is located

(iii) Secretary Health Member

(iv) | Commissioner of the Division Member

(v) _ A professional having substantial contribution to Member
the field of Medical Sciences recognized
nationally and internationally (nominated by the
Chief Minister)

(vi) | One reputed citizen from adjacent area of Sanghar Member
involved in philanthropy activities (nominated by

the Chief Minister)

(vii) Chairman, District Council Sanghar Member

(viii) One nominee of Academic Council Member

(ix) Director of the Institute Member/

Secretary

4. There shall be a separate non-lapsable fund for the Institute known as the Amendment of section "Shahdadpur Institute of Medical Sciences Fund.". 15(1) of Sindh Act No.

XI of 2011.
