An Act to provide for the establishment of the University known as the Shaheed Benazir Bhutto University of Veterinary and Animal Sciences at Sakrand.

WHEREAS it is expedient to provide for the establishment of the University known as the Shaheed Benazir Bhutto University of Veterinary and Animal Sciences at Sakrand and to provide for the matters connected therewith or ancillary thereto.

It is hereby enacted as follows:-

**CHAPTER-I**  
**PRELIMINARY**

1. (1) This Act may be called the Shaheed Benazir Bhutto University of Veterinary and Animal Sciences Sakrand Act, 2012.

(2) It shall come into force at once.

2. In this Act, unless there is anything repugnant in the subject or context-

(a) "Academic Council" means the Academic Council of the University;

(b) "affiliated college" means an educational institution affiliated to the University but not maintained or administered by it;

(c) "Authority" means any of the Authorities of the University specified in section 21;

(d) "Chancellor" means the Chancellor of the University;

(e) "Chairman" means the head of a Teaching Department;

(f) "college" means a constituent college or

affiliated college;

(g) "Commission" means the Higher Education Commission;

(h) "constituent college" means a college

maintained and administered by the University;

academic service on honorary basis;

(ep) "Officer" means any of the officer of the University specified in section 8;

(q) "prescribed" means prescribed by statutes, regulations or rules;

(r) "Principal" means the head of a constituent or affiliated college;

(s) "Pro-Chancellor" means the Pro-Chancellor of the University;

(t) "Professor Emeritus" means a retired Professor working in the University;

(u) "professional college" means a\_ college providing instruction in the courses of study leading to a degree in animal production, business management, veterinary sciences, fisheries and wildlife or such other subject or subjects as may be prescribed by regulations;

(v) "Pro-Vice Chancellor' means the Pro-Vice Chancellor of the University;

(w) "registered graduate" means a graduate of the University who has his name entered in the register maintained for the purpose;

(x) "Registrar" means the Registrar of the University;

"Research Officer" means a person engaged whole time by the University for research and equivalent in rank to a University Teacher;

"Senate" means the Senate of the University;

"statutes", "regulations" and "rules" means respectively the statutes, the regulations and the rules made under this Act;

"Syndicate" means the Syndicate of the University;

"teachers" — include Professors, | Associate Professors, Assistant Professors and Lecturers engaged whole time by the University or by the college for teaching degree, honours or postgraduate classes, and such other persons as may be declared to be teachers by regulations;

"Teaching Department" means a Teaching Department established and maintained or recognized by the University;

"University" means the Shaheed Benazir Bhutto University of Veterinary and Animal Sciences at Sakrand as constituted under this Act:

"University Teacher" means a whole time Teacher appointed and paid by the University, or recognized by University as such; and

"Vice-Chancellor" means the Vice-Chancellor of the University; and

## CHAPTER-II THE UNIVERSITY

The Shaheed Benazir Bhutto University of

Veterinary and Animal Sciences at Sakrand is established in accordance with the provisions of this Act.

(2)

The University shall consist of —

(i) the Chancellor, the Pro-Chancellor;

(a) at the main campus the Vice Chancellor, Deans, Principals of the colleges, Directors of the constituent institutions, Chairmen of Teaching Departments, Registrar, Director of Finance, Controller of Examinations, Chief Accountant, Resident Auditor and such other officers as may be prescribed; and

(6) at the additional campus, the Pro Vice-Chancellor, Deans, Chairmen of the teaching department and such other officers as may from time to time be appointed by the Chancellor on the recommendation of the Vice Chancellor.

(ii) the members of the Senate, the Syndicate, the Academic Council and other Authorities of the University;

(iii) all University Teachers; and

(iv) | Emeritus Professors:

Provided that the Chancellor on the recommendation of the Vice Chancellor may set up in any educational institution or college under the control and management of the University, a Board of Governors, in lieu of officers and employees mentioned in sub-clause (b) of clause (i).

(2) | The University shall be a body corporate by the name of Shaheed Benazir Bhutto University of Veterinary and Animal Sciences, Sakrand and \_ shall have perpetual succession and a common seal, and may sue and be sued by the said name.

(3) The University shall be competent to acquire and hold property, both movable and immovable, and to lease, sell or otherwise transfer any movable and immovable property which may have become vested in or been acquired by it.

4. The University shall have the powers -

(i) to provide for instructions in veterinary and animal sciences, social and natural sciences, humanities and such other branches of learning as it may

deem fit, and to make provisions for research and for the advancement and dissemination § of knowledge in such manner as it may determine:

- (ii) to prescribe courses of studies to be conducted by it and the college;
- (iii) to admit and examine students and to confer or award degrees, diplomas, certificates and other academic distinctions on the persons who have passed its examinations under the prescribed conditions;
- (iv) to affiliate itself or associate with other institutions within and outside the country and establish faculties and the teaching departments to discharge its functions and responsibilities for the betterment of education;
- (v) to confer, subject to the approval of the Chancellor on the recommendations — of Government, honorary degrees or other distinctions on approved persons in the manner prescribed;
- (vi). to provide such instruction for persons not being students of the University as it may determine and to grant certificates and diplomas to such persons;
- (vii) to confer degrees on persons who have carried on independent research under prescribed conditions;
- (viii) to affiliate and disaffiliate educational institutions under prescribed conditions;
- (ix) to admit educational institutions to its privileges and to withdraw such privileges under prescribed conditions;
- (x) to inspect colleges and other educational institutions associated or seeking association with it;
- (xi) to accept the examinations passed and the periods of study spent by students of the University at other Universities and places of learning as equivalent to such examinations and periods of study in the University, as it may determine, and to withdraw such acceptance;

(xii) to Cooperate with other Universities and public authorities in such manner and for such purposes as it may determine;

(xiii) to institute Professorships, Associate Professorships, Assistant Professorships, Senior Registrarships and Lecturerships and any other posts and to appoint persons thereto;

(xiv) to create posts for research, extension, administration and other related purposes and to appoint persons thereto;

(xv) to recognize selected members of the teaching staff of colleges or educational \_ institutions admitted to the privileges of the University or such other persons as it may deem fit, as University Teachers;

(xvi) to institute and award fellowships, scholarships, exhibitions, bursaries, medals and prizes under prescribed conditions;

(xvii) to establish faculties, teaching departments, research \_ institutes, centers of excellence, museums and other learning centers for the development of teaching and research and to make such arrangements for their maintenance, management and administrations as it may determine;

(xviii) to control the residence of the students of the University and the colleges and constituent institutes as per policy framed by the University;

(xix) to institute and maintain halls of residence and to approve or licence hostels and lodgings;

(xx) to supervise and control the discipline of the students of the University, constituent colleges and institutes, to promote the extracurricular and recreational activities of such students, and to make arrangements for promoting their health and general welfare;

(xi) to demand and receive such fees and other charges as it may determine;

(xxii) to make provision for research and advisory services and with these objects to enter into arrangements with Government, organizations, institutions, bodies and — individuals under prescribed conditions;

(xxiii) to enter into, carry out, vary or cancel contracts;

(xxiv) to acquire, receive and manage property, grants, bequests, trusts, gifts, | donations, endowments and other contributions made to the University and to invest them in such manner as it may deem fit;

(xxv) to provide for the printing and publication of research and other works;

(xxvi) to do all such other acts and things, whether incidental to the powers aforesaid or not, as may be requisite in order to further the objects of the University as a place of education, learning and research.

5. (1) The University shall exercise the powers conferred on it by or under this Act within the territorial limits and in respect of the institutions as specified by Government:

Provided that Government may, in consultation with the University, by general or special order, modify the extent and scope of the aforesaid powers of the University with regard to such territorial limits of institutions.

(2) No educational institution of veterinary and animal sciences situated within the territorial limits of the University shall, save with the consent of the University and the sanction of Government, be associated in any way with or seek admission to the privileges of any other University.

(3) | The University may admit to its privileges under the prescribed conditions, an educational institution falling within the territorial limits of another University whether inside or outside Pakistan, provided that consent of such other University is first obtained.

(4) | The University may establish its campuses within or outside the Province of Sindh.

Jurisdiction of the University.

6. (1) The University shall be open to all persons of University open either sex of whatever religion, race, creed, caste, class or to all classes, colour who are academically qualified for admission to the creeds, etc. courses of study offered by the University, and no such

person shall be denied the privileges on the ground only of

sex, religion, race, creed, caste, class or colour:

Provided that nothing in this section shall be deemed to prevent religious instructions being given to the students in their own religious faiths in such manner as may be prescribed.

(2) The policy of admission to the constituent colleges and constituent institution in force immediately before the commencement of this Act shall continue until modified by the Syndicate.

7. (1) All recognized teaching in various courses shall Teaching at the be conducted by the University or the colleges in the University. prescribed manner and may include lectures, tutorials,

discussions, seminars, demonstrations, as well as practical

work in the laboratories, workshops, farms and other

methods of instructions.

(2) The authority responsible for organizing recognized teaching shall be such as may be prescribed.

(3) The courses and the curricula shall be such as may be prescribed:

Provided that at the level of Bachelor's degree in all faculties, a discipline to be called the Islamic and Pakistan Studies discipline shall be compulsory for Muslim Students, and non-Muslim students shall, in lieu of such discipline, have option to have Ethics and Pakistan Studies.

**CHAPTER-III  
OFFICERS OF THE UNIVERSITY**

8. The following shall be the Officers of the University:- Officers of the University.

- (ii) the Pro-Chancellor;

- (viii) the Registrar;
- (ix) the Controller of Examinations;
- (x) the Director Planning and Development;
- (xi) | the Director of Finance;
- (xii) the Librarian;
- (xiii) the Resident Auditor;
- (xiv) the Chief Accountant;
- (xv) the Bursar; and
- (xvi) such persons as may be prescribed by the regulations to be the officers.

9. (1) | The Governor of Sindh shall be the Chancellor of the University.

(2) The Chancellor shall, when present, preside at

the convocation of the University and the meetings of the Senate.

(3) If the Chancellor is satisfied that the proceedings of any Authority are not in accordance with the provisions of this Act, the statutes, the regulations or the rules, he may, after calling upon such Authority or officer to show cause why such proceedings or orders should not be annulled, by order in writing, annul the proceedings.

(4) Every proposal to confer an honorary degree shall be subject to confirmation by the Chancellor.

(5) The Chancellor shall have the power to assent to such statutes as are required to be submitted to him by the Senate or withhold assent or refer them back to the Senate for reconsideration.

(6) The Chancellor may remove any person from

the membership of any Authority if such person —

(i) has become of unsound mind; or

(ii) has been incapacitated to function as  
member of such Authority; or

(iii) has been convicted by a court of law for  
an offence involving moral turpitude.

10. (1) The Chancellor may cause an inspection or Visitation.  
inquiry to be made in respect of any matter connected with

the University, and shall, from time to time, appoint such

person or persons in consultation with the Government for

the purposes of carrying out inspection of -

(i) the University, its buildings, laboratories,  
libraries, museums, workshops and  
equipment;

(ii) any institution, college or hostel maintained  
or recognized by or affiliated to the  
University;

(iii) the teaching and other work conducted by  
the University; and

(iv) the conduct of examinations held by the  
University;

(2) The Chancellor shall, in every such case as  
aforesaid, give notice to the Syndicate of his intention to  
cause an inspection or enquiry to be made, and the  
Syndicate shall be entitled to be represented there-at.

(3) The Chancellor shall communicate to the  
Syndicate his views with regard to the results of such  
inspection or inquiry and shall, after ascertaining the views  
thereon of the Syndicate, advise the Syndicate on the  
action to be taken.

(4) The Syndicate shall communicate to the  
Chancellor such action, if any, as has been taken or may be  
proposed to be taken upon the results of the inspection or  
inquiry within such time as may be specified by the  
Chancellor.

(5) Where the Syndicate does not, within a  
specified time, take action to the satisfaction of the

Chancellor, the Chancellor may, after considering any explanation furnished or representation made by the Syndicate, issue such directions as he thinks fit, and the Vice Chancellor shall comply with such directions.

11. (1) ~~) The Minister for Livestock and Fisheries shall be the Pro-Chancellor of the University.

(2) Should the Chancellor be incapacitated from acting as such due to absence or any other cause, the Pro-Chancellor shall exercise all the powers and perform all the duties of the Chancellor.

12. (1) There shall be a \_ Vice-Chancellor of the University who shall be an eminent academician and a distinguished administrator and registered member of the Pakistan Veterinary Medical Council, and shall be appointed by the Chancellor on the advice of Government for a period of four years which may be extended for one more term on such terms and conditions as Government may determine.

(2) At any time when the office of the Vice-Chancellor is vacant, or the Vice Chancellor is absent or is unable to perform the functions of his office due to illness or some other cause, the Chancellor shall, on the advice of Government, make such arrangements for the performance of the duties of the Vice Chancellor.

13. (1) The Vice Chancellor shall be the principal executive and academic officer of the University, and shall ensure that the provisions of this Act, the statutes, the regulations and the rules are faithfully observed in order to promote the general efficiency and good order of the University. He shall have all powers necessary for this purpose including administrative control over all officers, teachers and other employees of the University.

(2) | The Vice Chancellor shall, in the absence of the Chancellor and Pro-Chancellor, preside at the convocation of the University and the meetings of the Senate and shall, if present, preside at the meetings of the Authorities of which he is the Chairman and be entitled to attend and preside at any meeting of any other Authority or body of the University.

(3) The Vice Chancellor may, in an emergency, which in his opinion requires immediate action, take such action as he may consider necessary and shall, as soon thereafter as possible, report his action to the officer, authority or other body which in the ordinary course, would have dealt with the matter.

(4) | The Vice Chancellor shall also have the powers -

(i) to create and fill temporary posts for a period not exceeding six months;

(ii) to sanction all expenditure provided for in the approved budget, and to re-appropriate funds within the same major head of expenditure;

(iii) to sanction by re-appropriation an amount not exceeding rupees one lac for an unforeseen item not provided for in the budget, and report it to the Syndicate at the next meeting;

(iv). to appoint paper setters and examiners for all examinations of the University after receiving panels of names from the relevant authorities;

(v) to make such arrangements for the scrutiny of papers, marks and results as may be necessary;

(vi) to direct teachers, officers and other employees of the University to take up such assignments in connection with teaching, research, examination, administration and such other activities in the University as he may consider necessary for the purpose of University;

(vii) to delegate, subject to such conditions, if any, as may be prescribed, any of his powers under this Act to an officer or officers of the University;

(viii) to make appointments to the posts in all grades of the basic scales of pay upto BS-16; and

(ix) to exercise and perform such other powers and functions as may be prescribed.

14. (1) The Chancellor may, on the advice of Government and in consultation with the Vice Chancellor, appoint a Pro-Vice Chancellor for the main campus or of the additional campus, if any, or for both the campuses jointly or separately, on such terms and conditions and for such period not exceeding four years at a time as Government may determine.

(2) Where a Pro-Vice Chancellor is appointed under sub-section (1), he shall, notwithstanding anything contained in this Act, exercise such powers and perform such functions of the Vice Chancellor or such other powers and functions, in respect of the campus for which he is appointed, as the Chancellor may delegate to him.

(3) | The Pro-Vice Chancellor, if appointed, shall be ex-officio member of the Senate, Syndicate and Academic Council.

15. (1) The Registrar shall be a whole-time officer of the University and shall be appointed by Chancellor on the advice of Government on such terms and conditions as it may determine.

(2) The Registrar shall —

(a) hold office for a period of three years on the expiry of which he shall be eligible for re-appointment;

(b) be the custodian of the common seal and the academic records of the University;

(c) maintain a register of registered graduates in the prescribed manner;

(d) conduct election of members to the various authorities in the prescribed manner; and

(e) perform such other duties as may be prescribed.

16. (1) The Director of Finance shall be a whole-time officer of the University and shall be appointed by Chancellor on the advice of Government on such terms and conditions as it may determine.

(2) | The Director Finance shall -

(a) manage the property, finances and the investments of the University;

(6) prepare the annual and revised budget estimates of the University and present them to the Finance Committee, the Syndicate and the Senate;

(c) ensure that the funds of the University are expended for the purposes for which they are provided; and

(d) perform such other duties as may be prescribed.

(3) The Director of Finance shall be assisted by the Chief Accountant and the Resident Auditor.

17. (1) ~~ The Resident Auditor shall be whole-time officer of the University and shall be appointed by the Chancellor on the advice of Government on such terms and conditions as it may determine.

(2) The Resident Auditor shall be responsible for all matters connected with the auditing of accounts of the University and shall perform such other duties as may be prescribed.

18. The Controller of Examinations of the University shall be a whole-time officer of the University and shall be appointed by the Chancellor on the advice of Government and shall be responsible for all matters connected with the conduct of examinations and perform such other duties as may be prescribed.

19. The Director Planning and Development shall be a whole time officer of the University and shall be appointed by Government on such terms and conditions as it may determine.

20. ~All the other remaining officers mentioned in section 8, shall be appointed by such officer or authority as authorized by Government on such terms and conditions as it may determine. They shall perform their duties as may be prescribed.

(iv) that the educational institution has framed proper rules regarding the efficiency and discipline of its staff and other employees;

(v) that the building in which the educational institution is to be located is suitable, and that provision will be made in conformity with the statutes and the regulations for the residence of students, not residing with their parents or guardians, in the hostels established and maintained by the educational institution or in hostels or lodgings approved by it, and the supervision and physical and general welfare of students;

(vi) that provision has been made for Library and adequate library services;

(vii) that where affiliation is sought in any branch of experimental sciences, due arrangements have been made for imparting instruction in that branch of science in a properly equipped laboratory, museum and other places of practical work;

(viii) that due provision shall, so far as circumstances may permit, be made for the residence of Principal and members of the teaching staff in or near the college or the place provided for the residence of students ; and

(ix) that the affiliation of the educational institution, having regard to the provision which may have been made for students by another educational institution in its neighborhood, will not be injurious to the interests of education or discipline.

(2) The application shall further contain an undertaking that after the educational institution is affiliated any transference of, and changes in the management and in the teaching staff shall be forthwith reported to the University, and that the teaching staff shall possess such qualifications as are or may be prescribed.

(3) | The procedure to be followed in disposing of an application for the affiliation of an educational institution shall be such as may be prescribed.

(4) | The Syndicate may, on the recommendation of the Affiliation Committee, grant or refuse affiliation to an educational institution:

Provided that affiliation shall not be refused, unless the educational institution has been given an opportunity of making a representation against the proposed decision.

(1) Where an order is passed punishing any officer (other than the Vice Chancellor), teacher or other employee of the University or altering or interpreting to his disadvantage the prescribed terms or conditions of his service, he shall, where the order is passed by the Vice Chancellor or any other officer or teacher of the University, have the right to appeal to the Syndicate against the order, and where the order is made by the Syndicate, have the right to apply to the Syndicate for review of that order.

(2) The appeal or application for review shall be submitted to the Vice Chancellor and he shall lay it before the Syndicate with his views alongwith the record of the case.

(3) No order in appeal or review shall be made unless the appellant or the applicant, as the case may be, has been given an opportunity of being heard.

If a question arises whether any person is entitled to be a member of any Authority, the matter shall be referred to a committee consisting of the Vice Chancellor and the Judge of the High Court and the senior most Dean, who are the members of the Syndicate and the decision of the committee shall be final and binding.

Notwithstanding anything contained in this Act, the statutes set out in the Schedule to this Act, shall be deemed to be the statutes framed under section 30 and shall continue to remain in force until amended or replaced until new statutes are framed in accordance with the provisions of this Act.

51. No court shall have jurisdiction to entertain any proceedings, grant any injunction or make any order in relation to anything done in good faith or purported to have been done or intended to be done under this Act.

52. No suit or legal proceedings shall lie against Government, the University or any Authority, officer or employee of Government or University or any person in respect of anything which is done or purported to have been done in good faith or is intended to or has been done under this Act.
