THE SINDH LAWS (AMENDING AND REPEALING) ACT, 1993
[20th February, 1994]

An Act to amend and repeal certain laws in force in the
Province of Sindh.

WHEREAS it is expedient to amend and repeal certain laws Preamble.
which are spent or have become un-necessary or ceased to be
in force otherwise than by express repeal:

is hereby enacted as follows:-

1. (1) This Act may be called the Sindh Laws (amending and _ Short title and
Repealing) Act, 1993. commencement.

(2) It shall come into force at once.

2. In the Good Conduct Prisoners' Probational Release Act, Amendment _ of

(iii) in section, 27, in sub-section (2), in clause (XXVIII),
the word "People's", shall be deleted.

4. In the Sind Deti Leti Act, 1939, in section 12, in sub-section Amendment _ of

5. In the Soil Reclamation Act, 1952, as applicable to Sindh, Amendment of
in section 4, in sub-section (1), in clause (c), the words "West Act, XXI of 1952.
Pakistan" shall be deleted.

THE SINDH LAWS (AMENDING AND REPEALING) ACT, 1993

In the Sindh Children Act, 1955—

(i) in section 20, sub-section (2), shall be deleted;

(ii) in section 97, for the figure “1929”, the figure “1955”, shall be substituted;

(iii) section 99 and proviso thereunder, shall be deleted.

In the Sindh Cultural Advancement Board Act, 1955—

(i) in section 13, in clause (vi), for the words, comma and figure “Sind People’s Local Government Ordinance, 1972” the words, comma and figure “Sind Local Government Ordinance, 1979”, shall be substituted.

(ii) In section 17, 29 and in the Schedule, the word “People’s”, shall be deleted.
