THE SINDH LAWS (SECOND AMENDMENT) ACT, 2012
[19th March, 2013]

An Act to amend certain laws in force in the
Province of Sindh.

WHEREAS it is expedient to amend certain laws in Preamble.
force in the Province of Sindh;

It is hereby enacted as follows:-

1. (1) This Act may be called the Sindh Laws (Second Short title and
Amendment) Act, 2012. Commencement.

(2) It shall come into force at once and shall be
deemed to have taken effect on and from 5th
November, 2011.
