

SINDH ACT NO.VI OF 1991

An Act to amend the Sind Service Tribunals Act, 1973.

WHEREAS it is expedient to amend the Sind Service Tribunals Act, 1973 , in the manner hereinafter appearing;

It is hereby enacted as follows: —

1. (1) This Act may be called the Sindh Service Tribunals

(Amendment) Act, 1991.

(2) It shall come into force at once.

2. In the Sind Service Tribunals Act, 1973, hereinafter

referred to as the said Act, in section 2, in clause (c) before the fullstop at the end, the words and figure “or section 3-B, shall be

added.

3. In the said Act, after section 3-A, the following new sections shall be inserted: -

“3-B.
