THE SIND SPEAKER'S AND DEPUTY SPEAKER'S (SALARIES, ALLOWANCES AND  
PRIVILEGES) ACT, 1975

An Act to provide for the salaries, allowances and  
privileges of Speaker and Deputy Speaker of the Provincial  
Assembly of Sind.

WHEREAS it is required by clause (1) of Article 250 of the  
Constitution of the Islamic Republic of Pakistan that within two  
years from the commencing day of the Constitution, provision  
shall be made by law for determining the salaries, allowances  
and privileges of the Speaker and Deputy Speaker of the  
Provincial Assembly;

It is hereby enacted as follows:-

1. (1) This Act may be called the Sind Speaker's and Deputy  
Speaker's (Salaries, Allowances and Privileges) Act, 1975.

(2) It shall come into force at once.

2. In this Act, unless there is anything repugnant in the  
subject or context—

(a) "Assembly" means the Provincial Assembly of Sind;

(b) "family" means the wife, legitimate and step children  
residing with and wholly dependent upon the  
Speaker or Deputy Speaker, as the case may be;

(c) "Government" means the Government of Sind;

(d) "maintenance" in relation to a residence includes  
the payment of local rates and taxes and the  
charges of electricity and water;

(e) "Speaker" means the Speaker of the Assembly;

(f) "Deputy Speaker" means the Deputy Speaker of the  
Assembly;

"Official residence" means the house reserved from  
time to time for use by a Speaker or Deputy Speaker  
as the case may be, and includes the staff quarters  
and other buildings and garden apartment thereto.

3. The Speaker or the Deputy Speaker as the case may be,  
shall, for the journey, from his ordinary place of residence to the  
seat of Government for the purpose of assuming office and,  
from the seat of Government to his Ordinary place of residence

Provided that the journey is performed not later than six months from the date of taking up office or, as the case may be, from the date of laying down office.

2["3-A. The Speaker or the Deputy Speaker shall, on his first election as Equipment such, receive an equipment allowance of s[\*\*\*] 4[\*\*\*] 7['fifty allowance. thousand" ]rupees, respectively.

Provided that the equipment allowance shall not be drawn if an allowance for the same purpose has been drawn previously upon his appointment or election to the office of Chief Minister, Minister, Speaker or Deputy Speaker during the tenure of the Assembly for which he has been elected as Speaker or Deputy Speaker." ]

4. The Speaker or Deputy Speaker, as the case may be, shall not be required to sign a charge report on taking up or laying down his office.

5[5. (1) The salary of the Speaker and Deputy Speaker, shall respectively be 8["one hundred fifty thousand and one hundred forty thousand") rupees per mensem. Salary.

(2) | The Salary mentioned in sub-section (1), shall automatically be increased by Government in proportion increase in salary of civil servants.".]

Official Residence.

6['(1) The Speaker or the Deputy Speaker, as the case may be, shall be entitled to the use of an official residence including accommodation on tour through out his term of office, and for a period of fifteen days immediately thereafter, and the charges for its maintenance including the electricity

(2-A) The quality of the material provided in an official residence shall be in accord with the decision of a Committee consisting of the Chief Secretary, Finance Secretary and the Secretary Communications and Works Department." ]

for official or private use through out the term of his office and

9. (1) Subject to the provisions made hereinafter, the Travelling Speaker or the Deputy Speaker, as the case may be, travelling allowance for on official duty shall be treated as a Government Servant of the touring in first grade. Pakistan.

(2) | Journey by Air—The Speaker or the Deputy Speaker as the case may be, travelling on duty by air, shall be entitled to---

(a) asingle air fare for 3["first"] class;

(c) 4[(c) requisition, at the cost of Government, if he considers it necessary in the public interest a Pakistan Air Force aeroplane or an aeroplane belonging to Government subject to availability, and in accordance with the rules made by the Federal Government or the Provincial Government, as the case may be;

(d) take with himself his wife, whether travelling by a commercial aeroplane or by a\_ requisitioned aeroplane:

Provided that no non-official shall be allowed to travel in a Pakistan Air Force aeroplane without the authority of the Ministry of Defence;

(e) cost of transporting upto two personal servants by the lowest class of accommodation by rail or steamer";

Note: I.-- The Speaker shall, in addition to above, be entitled to the cost of transporting not more than two personal servants by rail in the lowest class.

Note: II.-- Wherever possible, the Speaker or the Deputy Speaker, as the case may be, shall purchase return air tickets.

i'(3) The Speaker, or the Deputy Speaker, as the case may be, when travelling on duty by rail in Pakistan, shall be entitled to—

(a) requisition at the cost of Government—

(i) an ordinary first-cum-second class carriage or a class tourist car or an 'A' Class tourist car, if a 'B' class tourist car is not available; or

(ii) if the vehicles specified at (i) above are not available, or are not desired, an ordinary four berthed first class compartment or a two berthed air-conditioned (coupe) compartment;

(b) take with himself in the reserved accommodation without payment of any fare, his family members not exceeding four when travelling in a requisitioned railway compartment.

(4) The Speaker, or the Deputy Speaker, as the case may be, reserving accommodation in the railway shall be required, before beginning the journey, to have the number and other details of the tickets purchased for the persons travelling with him in the reserved accommodation entered on the requisition form by the Station Master of the Station from which the journey is to commence.]

(5) Journey by Steamer or Launch.— The Speaker or the Deputy Speaker, as the case may be, travelling on duty by a steamer or launch, shall be entitled to—

(a) draw the actual fare paid for himself;

(6) take with him not more than two personal servants in the lowest class; and

(6) | Journey by Road.--- The Speaker or the Deputy  
Speaker, as the case may be, travelling on duty, by road,  
between places, not connected by railway, or when so  
connected he chooses to forego the privileges admissible to  
him under this section for rail journey, he may, where the  
journey is performed in a vehicle not owned or maintained by  
Government, draw---

(a) travelling allowance at the rate of 1["Three rupees  
per milometer"] for self; and

(6) actual expenses of the transport of—

(i) two private servants; and

(ii) all his personal luggage, including stores  
carried for consumption on tour.

2["9-A (1) If the Speaker, or the Deputy Speaker, as the case  
may be, while traveling by air, On official duty by any flight,  
scheduled or un scheduled (including flight in a Government  
owned aircraft of any type) dies "Or receives an injury as a  
result of any accident, the Government shall pay to person or  
persons referred to in sub-S4!Ction(2), a sum of three hundred  
thousand rupees, in case of death and an amount to  
determined by Government having regard to scales of  
compensation applied by insurance companies in like cases, in  
cue of injury.

(2) The compensation shall be payable in case of

10. (1) The Speaker and the Deputy Speaker shall, during the tour on official duty, be respectively entitled to draw a daily allowance of i[\*\*\*\*\*] 2[\*\*\*] 3 [\*\*\*]6[“two thousand and one

thousand and five hundred”] rupees for the duration of halts:

Provided that half Daily Allowance shall be admissible for the day of arrival, the day of departure and the day of both arrival and departure.

(2) For a halt exceeding ten days the daily allowance shall be admissible at the full rate for the first ten days, at the three-fourth of the full rate for the next twenty days or part thereof and at one-half of the full rate for the remaining period:

Provided that a halt is not interrupted by an absence for a period not less than seven nights, beyond five miles from the halting place.

Residence Maintenance Allowance (Instead of Furnishing Government/Private Residence) Rs.70, 000/= for Chief Minister and Rs.50, 000/= for Minister respectively per month.

Compensation in case of Air or Road Accident Rs.  
50,00,000/= for Chief Minister and the Minister respectively.

11. The Speaker shall be the Controlling Officer for the

purpose of travelling allowance admissible under this Act.

12. The Speaker or the Deputy Speaker, as the case may be, shall be entitled to medical facilities as admissible under the Special Medical Attendance Rules, 1950; provided that he and his family shall be entitled to medical attendance at his

residence.

13. 4[ (1) The Governor may, at one time or from time to time, for reason of health or private affairs grant to the Speaker or the Deputy Speaker, as the case may be, leave of absence s[for a

period not exceeding three months in a year". ]

1["14. The Speaker or the Deputy Speaker as the case may be, while travelling on official business outside Pakistan shall be entitled to First Class air fare and such allowance as may be specified by Government.

"15. (1) The Speaker or the Deputy Speaker, as the case may be, may, at his option, become a subscriber to the General Provident Fund, and if he so opts, he shall subscribe to the fund as a compulsory subscriber in accordance with the General Provident Fund Rules applicable to Provincial Government Servants.

(2) A temporary advance may be granted to the Speaker or the Deputy Speaker as the case may be from the amount standing to his credit in the General Provident Fund at the discretion of Government for the purpose for which such advance may be granted to as a subscriber under the said rules.

(3) The grant of a temporary advance under sub-section(2), shall, unless the Government otherwise directs, 00 subject to the condition to which an advance granted to a subscriber under the said rules is subject.

16. (1) The Speaker, or the Deputy Speaker as the case may be, may, while holidaying abroad, draw his full pay in foreign currency, for the period of holiday spent abroad.

(2) When the Speaker Or the Deputy Speaker, as the case may be, is holidaying abroad and draws his pay in foreign currency, he shall not be liable to pay Income- tax, provident fund subscription, etc., in foreign currency,, if he makes arrangement to pay such amount in rupees in Pakistan.

(3) The expenditure in foreign exchange involved under this Act shall be adjusted against the foreign exchange allocation placed at the disposal of the Government or each relevant shipping period.

(4) | Where the pay is drawn in foreign currency by the Speaker or the Deputy Speaker, as the case may be, he shall not be eligible to receive foreign exchange allocation from the State Bank of Pakistan in any other capacity.

17. The Government may make rules to carry out the purposes of this Act.

Power to make rules.

18. (1) Official residence, transport and furniture provided General.

to the Speaker or the Deputy Speaker, as the case may be, shall be used with the same care as is shown in respect of a person's own property.

(2) — All furniture and furnishings provided in an official residence of the Speaker or the Deputy Speaker, as the case may be, shall be marked for the purpose of identification.

(3) | On occupying an official residence by the Speaker or the Deputy Speaker, as the case may be, the furniture and furnishings in that residence shall be handed over to him or a person authorized by him in writing in this behalf according to an inventory to be drawn up for this purpose and signed by the officer in charge of Government buildings of that area.

(4) when the Speaker or the Deputy Speaker, as the case may be, is about to vacate the official residence, he shall inform the officer incharge of Government buildings in that area and a arrange to hand over the furniture and furnishings of such official residence to that officer according to an inventory to be drawn up for this purpose and signed by the Speaker or the Deputy Speaker, as the case may be.

(5) The officer in charge of Government buildings, may, from time to time with the prior approval of the Soeaker or the Deputy Speaker, as the case may be, inspect his official residence and the furniture and furnishings lying therein.

19. The Sind Speaker's and Deputy Speaker's (Salaries, Repeal.

Allowances and Privileges) Act, 1972 and the Sind Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) (Amendment) Act, 1974, are hereby repealed. ]

1[20. A person who has remained Speaker for not less than four years, on expiry of his term, shall be entitled for the following perks and privileges during his life time:-

(i) Seventy percent of the salary and allowances per mensem;

(ii) One Private Secretary of BS-17
