

SINDH ACT NO. XXXII OF 2013.

THE SINDH SPEAKER'S AND DEPUTY SPEAKER'S (SALARIES, ALLOWANCES AND PRIVILEGES) (AMENDMENT) ACT, 2009.

[1s' April, 2013]

An Act to amend the Sind Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975.

WHEREAS it is expedient to amend the Sind Speaker's Preamble. and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975, in the manner hereinafter appearing;

It is hereby enacted as follows:-

(1) This Act may be called the Sindh Speaker's and Deputy Short title and Speaker's (Salaries, Allowances and Privileges) (Amendment) commencement. Act, 2009.

(2) It shall come into force at once and shall be deemed to have taken effect on and from 15<sup>th</sup> July, 2011.

In the Sindh Speaker's and Deputy Speaker's (Salaries, Amendment of Allowances and Privileges) Act, 1975, hereinafter referred as Section 3-A of the said Act, in Section 3-A, for the words "five thousand", the words "seven thousand" shall be substituted. —

In the said Act, for section 5, the following shall be inserted:- Amendment of Section 5 of the Sind Act No. VII of 1975.

"5 (1) The Salary of the Speaker and Deputy Speaker, shall respectively be eighty thousand and seventy thousand rupees per mensem.

(2) The Salary mentioned in sub-section (1), shall automatically be increased by Government in proportion increase in salary of civil servants."

PRIVILEGES) (AMENDMENT) ACT, 2009.

In the said Act, in section 6, in sub-section (2), for the words “thirty nine thousand and five hundred”, and the words “thirty five thousand” the words “fifty five thousand three hundred” and words “forty nine thousand”, shall respectively be substituted.

In the said Act, for section 7, the following shall be

“7. The Speaker or Deputy Speaker, as the case may be, shall be entitled to use two official cars maintained at Government expenses.”

In the said Act, in section 8, for the words “six thousand”, — the words “eight thousand four hundred” shall be substituted.

In the said Act, in section 8-A, for the word “both”, the words “and a mobile phone on Government expenses” shall be substituted.

In the said Act, in section 10, for the words “five hundred fifty”, the words “seven hundred and seventy” shall be substituted.
