

THE SINDH UNIVERSITIES AND INSTITUTES LAWS (AMENDMENT) ACT, 2014.

[6 January, 2015]

An Act to amend the certain laws relating to the Universities and Institutes in force in the Province of Sindh.

WHEREAS it is expedient to amend the certain laws relating to the Universities and Institutes in force in the Province of Sindh, in the manner hereinafter appearing;

It is hereby enacted as follows:-

(1) This Act may be called the Sindh Universities and Institutes Laws (Amendment) Act, 2014.

(2) It shall come into force at once.

2. In the University of Sindh Act, 1972, in section 13, for sub-section (1), the following shall be substituted:-

“(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

3. In the University of Karachi Act, 1972, in section 13, for sub-section (1), the following shall be substituted:-

“(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

4. In the N.E.D. University Act, 1977, in section 27, for sub-section (1), the following shall be substituted:-

“(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.

5. In the Mehran University of Engineering and Technology Act, 1977, in section 27, for sub-section (1), the following shall be substituted:-

“(1) There shall be a Vice Chancellor of the University who shall

be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

“(1-A) Notwithstanding anything contained in this Act or any other law, for the time being in force, any person who had ceased to hold office as the Vice Chancellor in consequence of enactment of the Sindh Universities Laws (Amendment) Act, 2013 (Sindh Act No.XLIII of 2013), Government may, keeping in view of his performance of such person, direct him to continue for a period of not more than two years as the Vice

Chancellor.”.

6. In the Sindh Agriculture University Act,1977, in section 27, for Amendmentin Sindh sub-section (1), the following shall be substituted:- Act No.V of 1977.

“(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

7. In the Shah Abdul Latif University Act,1986, in section 13, for Amendmentin Sindh sub-section (1), the following shall be substituted:- Act No.XI of 1986.

“(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

8. In the Institute of Business Administration Act, 1994, in section 9, Amendmentin Sindh for sub-section (1), the following shall be substituted:- Act No.XX of 1994.

“(1) There shall be a Director of the Institute who shall be an eminent academic or a distinguished administrator and shall be appointed by the Patron on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may

determine.”.

9. In the Quaid-e-Awam University of Engineering, Science and Amendmentin Sindh Technology, Nawabshah Act, 1996, in section 27, for sub-section (1), ActNo.XIX of 1996.

the following shall be substituted:-

“(1) There shall be a Vice Chancellor of the University who shall

be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

10. In the Liaquat University of Medical and Health Sciences Ordinance, 2000, in section 14, for sub-section (1), the following shall be substituted:-

“(1) A person having medical background shall be appointed as Vice Chancellor by the Chancellor on the advice of Government for a period of four years, which may be extended for one more term, on such terms and conditions as Government may determine.”.

11. In the Dow University of Health Sciences Act, 2004, in section 12, for sub-section (1), the following shall be substituted:-

“(1) A person having medical background shall be appointed as Vice Chancellor by the Chancellor on the advice of Government for a period of four years, which may be extended for one more term, on such terms and conditions as Government may determine.

(1-A). Notwithstanding anything contained in this Act or any other law, for the time being in force, any person who had ceased to hold office as the Vice Chancellor in consequence of enactment of the Sindh Universities Laws (Amendment) Act, 2013 (Sindh Act No.XLIII of 2013), Government may, keeping in view of his performance of such person, direct him to continue for a period of not more than two years as the Vice Chancellor.”.

12. In the Sukkur Institute of Business Administration Act, 2006, in section 12, for sub-section (1), the following shall be substituted:-

“(1) There shall be a Director of the Institute who shall be an eminent academic or a distinguished administrator and shall be appointed by the Patron on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

13. In the Shaheed Mohtarma Benazir Bhutto Medical University Larkana Act, 2008, in section 10, for sub-section (1), the following shall

be substituted:-

“(1) A person having medical background shall be appointed as Vice Chancellor by the Chancellor on the advice of

Government for a period of four years, which may be extended for one more term, on such terms and conditions as Government may determine.

14. In the Peoples University of Medical and Health Sciences for Women, Shaheed Benazirabad Act, 2009, in section 13, for sub-section (1), the following shall be substituted:-

“(1) A person having medical background shall be appointed as Vice Chancellor by the Chancellor on the advice of Government for a period of four years, which may be extended for one more term, on such terms and conditions as Government may determine.”.

15. In the Benazir Bhutto Shaheed University at Lyari, Karachi Act, 2009, in section 12, for sub-section (1), the following shall be substituted:-

“(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

16. In the Shaheed Benazir Bhutto University, Shaheed Benazirabad Act, 2009, in section 12, for sub-section (1), the following shall be substituted:-

“(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

17. In the Sindh Madressatul Islam University Act, 2012, in section 13, for sub-section (1), the following shall be substituted:-

“(1) There shall be a Vice Chancellor of the University who shall be eminent academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.

18. In the Shaheed Benazir Bhutto University of Veterinary and Animal Sciences Sakrand Act, 2012, in section 12, for sub-section (1), the following shall be substituted:-

“(1) There shall be a Vice Chancellor of the University who shall be a Professor of medical profession and eminent and academic or a distinguished administrator and shall be appointed by the Chancellor on the advice of Government, for a period of four years, which may be extended for one more term on such terms and conditions as Government may determine.”.
